M I N U T E S

PRESENT: Vice-Chairman - Daniel A. Rhodes

Mr. Poore was in the hospital and unable to attend. Mr. Rhodes called the meeting to order and Councilman Joey Wright gave the invocation.

Mr. Hooper presented a Resolution that until Mr. Poore is able to carry on the day to day activities Mr. Rhodes would act as stead. Motion was seconded by Mr. Kinley, after a short discussion, Council agreed to turn over to the County Attorney for his review.

On the motion fo Mr. Kinley, seconded by Mr. Wright, Council voted unanimously to approve the minutes from the September 7, 1982 meeting as mailed.

Mr. Mike Mullinax asked Council to approve Resolution #161 requesting that the annexation of Meadow Park Subdivision adjacent to the district boundaries of Homeland Park Water District, be allowed. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to approve the Resolution. Mr. Mullinax asked Council's approval on another Resolution & Petition (#162) asking that the Homeland Park Water District boundaries be extended and to allow for a public hearing as to whether to hold a public hearing and to what extent the boundaries may be enlarged. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to approve Resolution & Petition #162.

Dr. Gregg & Dr. Vines spoke on the deficiencies in the EMS System in Anderson County and explained the job of a paramedic. Mr. Rhodes asked Ms. Dobbins to set up a meeting with the EMS Commission and the EMS Council.

Mr. Watson asked for transfers within the Election Commission's budget as requested by Mr. Bill Gaston. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to allow the transfers. (See attached)

Mr. Hooper asked that Ms. Nancy Hellams be reappointed to the Mentally Retarded Board. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to re-appoint Ms. Hellams for a four year term.

Mr. J.D. Compton spoke on the Airport property. He stated that if the property is not bringing in revenue to the people of Anderson County, he suggested that the County close it down. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to receive as information.

A public hearing was held for the citizens to present written or oral comments concerning the leasing of County property - known as the Anderson County Farm. Mr. Kinley stated that the land would be leased for one year at a time.

On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to close the public hearing.

Mr. Watson presented a rough estimate of the cost for furniture and furnishings for the Courthouse Judges. He stated that around \$24,000 would be needed for the furniture. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to send the furniture out on bid as soon as possible.

Mr. Watson asked Council to approve the purchase of a 3100 Xerox copy machine for the Purchasing Office and County Council for \$2255 which would fill the needs for the least amount of money. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to allow the purchase.

Sealed bids were presented to County Council by Mr. Watson on signs, caps & spacers for Road Maintenance. He recommended that the County purchase from the low bid for \$10,337.47 from American Highway Company. On the motion of Mr. Bratcher, seconded by Mr. Kinley, Council voted unanimously to go with the low bid.

Mr. Watson discussed sealed bids for asphalt resurfacing. He stated that Sloan Construction Company was the low bidder, and explained that \$63,000 in District #6, \$62,000 - District #7, \$65,000-District #8, \$89,000-District #9, and \$75,000-District #10 was the amounts remaining in each district for resurfacing. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to let Sloan Construction Company do the resurfacing for the remaining amounts as listed above.

Mr. Watson discussed the bids for asphalt to be picked up at plant. He explained that it would be in the best interest of the County to issue purchase orders to all four companies and to haul from closest plant to job. On the motion of Mr. Kinley, seconded by Mr. Wright, Council voted unanimously to approve his recommendation.

Mr. Watson asked that the purchase of Malathion for vector control for Health Department be allowed through State Purchasing. On the motion of Mr. Bratcher, seconded by Mr. Hooper, Council voted unanimously to approve the \$4,243.20 purchase.

Mr. Karl Kenyon asked approval of third and final reading of Ordinance #95 - Amended Ordinance for Torrington. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve ORDINANCE #95 on third reading.

Mr. Hooper presented ORDINANCE #96 for approval on first reading for the County Farm Manager's house to be occupied by a Courthouse magistrate. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted two in favor and two opposed (Mr. Bratcher, and Mr. Wright voted against the motion.) The chairman voted in favor of the motion to break the tie.

Mr. Rhodes asked that Mr. George Sullivan and James C. Harbin be reappointed to the Tax Assessment Appeals Board. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to reappoint for a four year term.

Mr. Kinley presented Resolution #163 - Open House for the new County Office Building to be held on October 10, 1982 from 2-5 p.m. Mr. Trey Senn, the Anderson County Planning & Development Board and David Watson to carry out the directives. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve RESOLUTION #163.

Mr. Pat Flack asked Council if any money was available for the Human Resources Commission.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to get with Mr. Watson to see if any money would be available.

Mr. John Brown representing the community of Fairmont Road presented a petition to County Council requesting that Council close a short road running from Fairmont Road to the Old Jim Beatty Farm as this road is not the only access to this piece of property and both ends to this road have been closed for many years. Council agreed to let Mac Walters, County Engineer, check out the road.

Mr. Robert King asked Council for approval of Resolution #164 to authorize him to negotiate with appropriate Federal authorities for acquisition of the Naval Reserve Facility on North Fant Street. On the motion of Mr. Bratcher, seconded by Mr. Wright, Council voted unanimously to allow Mr. King to check into the matter.

Council adjourned at 9:50 p.m.
