To Whom It May Concern

I am writing to inform / seek protection from / bring to justice the Associations, Organizations and individuals who are responsible for causing continuous malicious vexations and brain damage by altering my cognitive senses and behaviours. This has prompted me to commit criminal acts and inflict grievous bodily harm to myself. I have also been used as a research tool and "guinea pig" ever since I have been to the Behavioural Health Foundation. These people have used their devices to invade the sanctity and privacy of my mind for training front line workers and researchers.

This device is a product from Hatch Securities and affiliated agencies. This involves a simple surgical procedure of implanting a micro ear piece and sonar thoracic device which are used to manipulate thought patterns and cognitive behaviours – to torture the mind daily as a neurological weapon. These individuals have surgically altered my mind and body, essentially a neurological execution.

The only way I became aware of this "neurological weapon" was the significant changes to my behaviour and thought processes which have left me near dead on more occasions than I can count. I have been forced to rely on drugs and alcohol which have led to my hospitalization and resulting in me committing crimes. My sedated condition has left me susceptible to suggestions that have left me entrapped for crimes which I would normally not have committed. I have been led into oncoming traffic in an attempt to murder me. I have suffered physical and neurological damage including ruptured discs and being infected by diseases from biological agents.

This device has been in operation since I was at the B.H.F. in 1999 – 2004 and continuously following, to date 2014+. My health and that of my family have been the target of malicious intentions.

These individuals focused their resources against politicians and members of social service positions to defame them and acquire their jobs as a political strategy. "Psychological Tools of War" and "Biological Weapons" to sedate and control their targets.

My father, Gary D.W. Smith, was run out of office as Fire and Safety Officer, my mother was paid off to retire. My grandmother was the victim of the same "Neurological Weapon" being used on her to clean out her veteran's pension and causing her to have a stroke which left her in a state of active dementia.
