Christian,

Clemson does not have bullets associated with this project, as the Power Grid Research line for \$75,000 was sponsored in the budget process by Representative Chip Limehouse. It is our understanding, based on a conversation with Rep. Limehouse at the time he introduced this amendment, that he sponsored these dollars in Clemson's budget to allow the Sustainable Institute in Charleston to work with Clemson on certain research. While it is anticipated that these dollars would be potentially used for research associated with the grid simulator, this project is not a part of the Grid Simulator project requested by Clemson University through the Executive Budget process. They are two different projects and are not married to each other. The \$3 million requested by Clemson is to be used to complete the Grid Simulator project in North Charleston and will be used to match a \$2.4 million grant from the Department of Energy and various private sector gifts. This project was unanimously approved by the Budget and Control Board recently. Thanks, Angie
