HI GOVERNOR HALEY,MY NAME IS TRACY LYNCH.AND I LIVE IN MYRTLE BEACH.TO LET YOU KNOW A LITTLE ABOUT ME.I AM A MOTHER OF TWO.ONE WHO IS 29 ,WITH TWO BEAUTIFUL GRANDCHILDREN.AND IM THE MOTHER OF A 6 YEAR OLD LITTLE BOY.WHO IS BEAUTIFUL IN EVERY WAY.MIND AND SOUL.HE IS JUST VERY MISUNDERSTOOD.YOU SEE I HAD HIM THE DAY AFTER MY 43rd BIRTHDAY.THIS WAS A BEAUTIFUL GIFT.AND WHEN HE WAS BORN,THE STATS AT THE HOSPITAL IN WEST VIRGINIA WERE I HAD HIM WAS GREAT.AND THEY WERE AMAZED OF HOW BEAUTIFUL HE WAS,HIS EYEBROWS SO DARK AND ARCHED.DO TO HIS AMERICAN INDIAN HERITAGE.WELL LIFE WAS BEAUTIFUL I ENJOYED EVERY MOMENT I HAD WITH THIS BEAUTIFUL HUMAN BEING THAT GOD GAVE ME.AND THE SMILE WOULD LIGHT UP A ROOM,THEN THE AGE OF TWO CAME.AND HE HAD TO GO TO THE DOCTORS FOR HIS TWO YEAR APPOINTMENT.ON THIS DAY THIS REGRETEFUL DAY IS WHEN ALL OF LIFE IN WITCH WE NEW CHANGED.HE HAD TO GET THE MMR SHOT.WITH IN TWO WEEKS OF THIS TIME,MY BEAUTIFUL BABY BOYHAD BREATHING ISSUES,THE AMBULANCE HAD TO PUT HIM ON A HEART MONITER FOR THE HEART WAS NOT BEATING AS FAST AS IT SHOULD.AND OXYGEN WAS PUT ON HIS BEAUTIFUL LITTLE FACE.AND THE FEVER WAS WAY UP.WE WERE SHIPPED TO THE CHILDRENS HOSPITAL.WERE WE SPENT TWO NIGHTS THANK GOD HE WAS OK AND GOT BETTER AND WE COULD GO HOME.THEY SAID IT WAS THE CROOP.WELL I STARTED TO NOTICE A DIFFERNECE IN MY SON RIGHT AFTER THAT,HE STARTED TO LOOK DAZED,AND THE TALKING THAT WAS THERE WENT BACKWARDS TO NON EXSISTTENT,HE WOULD JUST POINT.AND HE STARTED TO TOE WALK.SO HE HAD TO GO BACK TO THE DOCTOR AND SHE NOTICED THE TOE WALKING TO,SO NOAH MY SON HAD TO START THERAPY.THEY CAME TO MY HOME EVERY WEEK AND WORKED WITH HIM,HE STARTED TO TALK A LITTLE BUT IT SOUNDED ROBOTIC.AND THE TOE WALKING THEY SAID WAS A TEXTURE ISSUE,AND IT WAS LEFT AT THAT.WELL AFTER THE LOSS OF MY DEAR MOTHER TO CANCER,AND HER LIVING THREE STREETS FROM ME ,IT WAS DEPRESSING FOR ME TO STAY IN WEST VIRGINIA, SO I SOLD EVERY THING THERE AND NOAH AND I MOVED HERE TO SEE THE PALM TREES.WELL AFTER ALL THAT HAS ALREADY HAPPEND I FELT I MIGHT BE ABLE TO ENJOY LIFE JUST A LITTLE WHILE LOOKING AT THE BEAUTIFUL PALMS.THIS WAS ONLY A DREAM .THE HOUSE I BOUGHT HERE.WAS A BIG MISTAKE.GUN SHOTS ,DRUGS,AND PROSTITION ,EVERY WERE.SO I FIXED MY HOME UP NICE AND PUT IT UP FOR SALE.YOU CAN SEE IT.ON THE COMPUTER.306 CEDAR ST.UNIT 15 MYRTLE BEACH SC.29577.IT IS NOT MOVING AT ALL AND IF I LOWER THE PRICE ANYMORE I WILL BE TAKING A BIG LOSS,AND I CAN NOT AFFORD TO DO THAT THIS IS ALL I HAVE.I KNOW IT IS THE NEIGHBORHOOD.I KEEP TELLING ALL THE POLICE WHEN THEY COME IN HERE,THEY SHOULD BY MINE AND USE IT AS A DRUG STING HOUSE.ATLEAST YOU KNOW MINE DOES NOT HAVE ANY BED BUGS IN IT..LOL,,WELL LETS MOVE ON,SO MY SON STARTED TO TALK AND THINK ABOUT ONLY ONE INTEREST,AND THE TEXTURE ISSUE STARTED TO BE MORE THEN IN THE FEET.HE WOULD ROLL HIS FOOD IN HIS FINGERS IF THE TEXTURE FELT RIGHT IT WENT IN THE MOUTH,IF IT DID NOT IT WENT OFF THE SIDE OF THE PLATE.AND IN PUBLIC RESTROOMS HIS HANDS WOULD GO OVER HIS EARS.BECAUSE THE FLUSHING TOILETS,AND HAND DRYERS WOULD BOTHER HIS EARS TO THE POINT HE YELLS DONT USE THE HAND DRYERS UNTIL IM OUT OF HERE.SOME PEOPLE LISTEN TO HIM AND SOME PEOPLE LOOK AT HIM LIKE HE IS STRANGE.THIS IS WHEN I LOOK BACK AT THEM AND SAY MY SON CAN HEAR THINGS 50 PERSENT BETTER THEN YOU.SO TIME MARCHES ON AND IT IS TIME FOR THIS LITTLE 5 YEAR OLD TO BE THRUSTED INTO THIS CRULE WORLD ALL ON HIS OWN.THIS IS HARD FOR ANY MOTHER TO DO I KNOW,BECAUSE I ALREADY RAISED A CHILD TO BE A GREAT GROWN UP.BUT THIS ONE WAS A BIT HARDER FOR I FELT THE NEED TO HAVE AN UNCOMFORTABLE CONVERSATION WITH THE TEACHER HE WAS GOING TO HAVE.WITH EYES CRYING I EXPLAINED TO HER THAT ALTHOUGH MY SON WAS

VERY SMART I KNOW HE IS DIFFERNT,AND I DONT KNOW WHY.AND EXPLAINED SOME OF THE THINGS HE DOES.THAT WHEN THEY BROUGHT HIM OUT AT THE END OF THE DAY TO GET PICKED UP SOMEONE WOULD HAVE TO STAY WITH HIM BECAUSE HE MAY TAKE OFF ON THEM .UNTIL I GET THERE DUE TO HE HAS A WONDERFUL MEMEORY AND MAY DECIDE HE WOULD LIKE TO GO TO BROADWAY AT THE BEACH.AND YES HE WOULD KNOW HOW TO GET THERE FROM THE SCHOOL BUT HE ALSO MAY GET HIT BY A CAR GOING THERE.SO THEY WERE VERY GOOD ABOUT THIS .THEY WOULD HOLD HIS HAND TILL THEY SAW ME.HE WENT TO MYRTLE BEACH PRIMARY SCHOOL.BUT WHILE IN CLASS THEY STARTED TO NOTICE THINGS ABOUT HIM TO.HE WOULD GET UP ANS CIRCLE THE ROOM AND MAKE A SOUND LIKE A RACE CAR.AND WAS NOT VERY SOCIAL JUST WANTED TO DO HIS OWN THING.THEY TESTED HIM WHEN THEY TESTED ALL THE OTHER KIDS IN HIS GRADE AND SAID NOAH WAS VERY SMART.HE TESTED HIGHER THIS WAY THEN ANY OTHER CHILD.AND HE IS THE ONE THAT KNOWS HOW TO DO EVERY THING ON THE COMPUTER.BUT HE DOES HAVE THIS DISRUPTIVE BEHAVIOR,AND I TOLD THEM I THINK MY SON IS AUTISTIC.THE FIRST DAY OF SCHOOL I STAYED ,AND MY POOR LITTLE BOY HAD TO GO TO THE BATHROOM TO PEE PEE.BUT WHEN HE WAS DONE HE CAME OUT WITH HIS UNDERWEAR UP THANK GOD BUT HIS SHORTS AROUND HIS ANKLES.LOOKING ALL AROUND THE ROOM WITH HIS MOUTH HANGING OPEN IN AMAZMENT.OTHER KIDS LOOKED AT HIM WITH SMERKS ON THEIR FACES.AND I RAN TO HELP ME.THIS WAS SAD FOR MY SON.AND HE LOOKED PIDIFUL TO ME.SO THE TEACHER ASKED IF I WANTED THE SCHOOL TO HAVE HIM EVALUATED AND I SAID YES ,I WOULD LOVE AN ANSWER.SO SHE CAME IN AND LOOKED AT MY SON FOR ABOUT AN HOUR,WHILE THERE SHE IN HER REPORT WRITES THAT HE CAME UP TO HER AND ASKED HER WHAT SHE WAS DOING HERE.AND SHE SAID JUST WATCHING THE CLASS ,GO BACK TO YOUR SEAT.SO HE DID AND HE KEPT LOOKING AT HER .SO IN A FEW MINUTES HE GOT BACK UP AND POKED HER SHOULDER AND SAID ..I ASKED YOU WHAT YOU ARE DOING HERE? SHE TOOK THIS AS MY CHILD BEING FRIENDLY.AND SAID BECAUSE OF THIS HE IS ADHD,I DONT KNOW WHAT KIND OF FRIENDS SHE HAS BUT THAT WAS NOT HIM BEING FRIENDLY.BUT YES DESTERBED THAT SHE WAS THERE AND NOT HIS NORMAL TO HIM.BUT THE EASY ANSWER IS ADHD.THEY COULD THEN DRUG HIM AND MAKE A SOMBY OUT OF HIM TO MAKE THEIR JOB EASIER.I SAID OH NO .THE TEACHER TOLD ME SHE FEELS IT IS SOMETHING ELS,AND SAID YOU AND I ARE AROUND HIM MORE THEN ONE HOUR.BUT SHE WAS AFRAID TO SAY ANYTHING IN FEAR OF LOOSING HER JOB.I WONDER HOW MANY OTHER KIDS ARE ON THESE DRUGS THAT SHOULD NOT BE ?????THIS IS SAD.SO I WENT TO MY SONS FAMILY DOCTOR AND TALKED TO HIM ABOUT IT.HE THINKS THERE IS SOMETHING ELS TO AND SENDS ME TO MUSC.BUT I HAVE A YEAR WAIT TO GET THAT APOINTMENT .SO I PULL HIM OUT OF SCHOOL.BECAUSE THE SCHOOL DOES NOT UNDERSTAND HIM.WELL TIME GOES BY AND I GO TO A PIZZA HUT .AND THE WAITER COMES TO THE TABLE AND SEES NOAH AND SAYS WHAT SCHOOL DO YOU GO TO WELL I SAID MYRLE BEACH ELEMENTRY INSTED OF PRIMARY.HE BRINGS US OUR PIZZA AND SAYS ARE YOU SHURE YOU GO TO ELEMENTRY .WELL MOM ALERT GOES UP.I SAID TO THIS GUY WHY ,HE SAID HE GOES TO PRIMARY,THEN HE SAID THIS IS MY SECOND JOB I ALSO WORK IN THE KITCHEN AT THE SCHOOL I AM THE DISH WASHER.THEN HE SAYS I THOUGHT I KNEW YOUR SON HE COMES BACK IN THE KITCHEN WITH ME ALOT,HE LIKES TO WATCH ME DO THE DISHES,I SAID OH HE DOES.AND THIS PRAYED ON MY MIND NOT KNOWNG WHAT TO DO ABOUT THIS .BUT HE WAS PULLED OUT OF SCHOOL NOW ANYWAY.SO I LET IT DIE,THEN MONTHS LATTER MY GRANDAUGHTER WHO GOES TO THE SCHOOL BRINGS NOAH HIS YEAR BOOK THAT I PAID FOR AT THE START OF THE YEAR,AND NOAH AND I WERE LOOKING AT IT.AND ALL OF A SUDDEN HE STARTS TO YELL I DONT LIKE HIM.OVER AND OVER AGAIN.RUNNING BACK AND FORTH STIMMING,I SAID WHO ,HE SAID THE MAN IN THE BLUE SHIRT.I SAID POINT HIM OUT ,HE SAID NO I DONT WANT TO SEE HIM.I SAID YOU HAVE TO SO I KNOW WHO HE IS.SO HE POINTS AT HIM AND YELLS HIM.I SAID WHY NOAH.HE SAID HE SQUERTED ME IN THE EYE WITH A HOSE.AGAIN MOM ALERT.I SAID WHAT HOSE.HE SAID IN THE KITCHEN.NOW THIS IS A DIFFERNT KITCHEN WORKER,BUT THE OTHER GUY TOLD ME MY SON DOES GO BACK THERE.SO I BELIEVE HIM.AND NOAH DOES NOT KNOW HOW TO LIE.I STILL HAVE NOT DONE ANYTHING ABOUT THIS ,BUT I HAVE HAD PEOPLE TELL ME I SHOULD.BUT YES AS A MOTHER IT IS VERY WEIRD TO ME.SO WE GET OUR APOINTMENT AT MUSC.THEY TEST MY SO FOR 8 HOURS .AND THE DOCTOR TOLD ME THAT I HIT THE NAIL ON THE HEAD.MY SON IS AUTISTIC.THIS WAS A MIXED IMOTION AT THIS TIME .BOTH SAD FOR US BUT ALSO A RELEASE.KNOWING THAT NOW WE CAN FINALLY GET THE HELP WE NEED.SO AN ADVOCATE SENT ME A LETTER AND TOLD ME TO APPLY FOR DISABILITY FOR MY SON.THAT IT IS HIS RIGHT.SO I DID SO ,AND YOU KNOW WHAT HAPPEND NEXT IM SHURE IT WAS DENIED.FOR NO GOOD REASON AT ALL.THE REASON WAS HE DOES NOT QUALIFY FOR PAYMENTS ON THIS CLAIM ,BECAUSE YOU ARE NOT DISABLED OR BLIND UNDER OUR RULES.SO I LOOKED UP THE RULES FOR AUTISM DISABILITY AND THEY LIED.HOW DARE THEY LIE,ON A CHILD WHO CAN NOT LIE.THEY SHOULD BE ASHAMED OF THEIR SELVES.HIS PAPER WORK FROM THE MUSC STATES EVERYTHING THEY WERE ASKING FOR AS A REQUERMENT.DID THEY EVEN READ IT ALL THAT I SENT TO THEM.IT SAID (STRONGLY SUPPORT A DIAGNOSIS OF AUTISM SPECTRUM DISORDER.NOAH IS EXHIBITING SEVER AND PERVASIVE DEFICITS WITH REGARDS TO HIS SOCIAL INTERACTION AND COMMUNICATION SKILLS AND ALSO HAS A PATTERN OF REPETITIVE LANGUAGE,MOVEMENTS,AND BEHAVIORS,HIGH NEED OF ROUTINE AND SAMENESS RESTRICTED INTERESTS.AND UNUSUAL REACTIONS TO SENCORY STIMULI.) EVERY REQUERMENT THEY ASKED FOR .SO WHY ?HE NOW GOES TO YOUNG TALKERS ONCE A WEEK AND

WORKS ON SPEACH AND SOCIAL BEHAVIOR THERE.AND WE ARE STILL WAITING FOR AN OT APOINTMENT,WAITING FOR A YEAR.THEY ARE ALL SO BOOKED.AND NOAH NOW IS HOMESCHOOLED AND I GO UNDER SCAHS FOR SPEACIAL NEEDS CHILDREN.SO THE SCHOOL DOES NOT DEADIN HIS INTELLIGENCE WITH DRUGS.BECAUSE THAT IS WHAT HE HAS IN HIS CORNER IS THAT HE HAS A ABOVE AVERAGE INTELLIGENCE.HE JUST NEEDS TO BE IN HIS COMFORT ZONE,WITH OUT THE THINGS THAT WOULD DESTERB HIM.I DONT KNOW IF YOU CAN HELP ME OR NOT ,BUT I HAVE ENOUGH ON MY PLATE WITH THE LOOKS WE MAY GET FROM PEOPLE WHEN WE ARE OUT IN PUBLIC AND I HAVE TO TEACH PEOPLE EVERYWERE WE GO ON WHAT THE FLIGHT IN STIMMING IS.THIS WORLD IS CRULE.AS IF A PACK OF WOLFS WANTING TO EAT MY LITTLE LAMB.AND I HAVE JUST ABOUT HAD IT.I THOUGHT TO GET A BUNCH OF OTHER MOTHERS WHO FEEL THE SAME AND OUR STIMMING AUTISTIC CHILDREN AND PACK A LUNCH AND HAVE A PICNIC AT THE DISABILITY OFFICE.DO YOU THINK THEY WOULD HEAR US THEN...THESE DIABLATED CHILDREN WILL TAKE OVER THE OFFICE TRUST ME.I AM SORRY THIS WAS SO LONG.BUT IT NEEDED TO BE SO YOU UNDERSTAND THE WHOLE STORY.SO IF THERE IS ANYTHING YOU CAN DO,I KNOW YOU HAVE MANY MORE IMPORTANT THINGS TO DO .BUT THIS ONE IS IMPORTANT TO MY SON AND I ,YOU SEE I AM AN OLDER MOTHER WITH THE WORRY OF DEATH AT SOME POINT KNOCKING AT MY DOOR.AND WHEN IT COMES I WANT THE COMFORT IN KNOWING MY SON WILL BE ABLE TO HAVE WATER AND LIGHTS AND FOOD IF I AM NOT HERE ANYMORE.THIS I CRY ABOUT EVERY NIGHT WHILE LOOKING AT THIS BEAUTIFUL LITTLE BOY WITH SUCH A PURE SOUL AS HE SLEEPS.MY NUMBER IS 843-808-9525 AND I DONT FEEL IT WOULD BE FAIR TO HAVE TO WAIT ANOTHER YEAR BEFORE I CAN BUY HIM THE SPEACIAL THINGS HE NEEDS ,LIKE THE SENCORY LED CARPIT THEY ARE 600 DOLORS AND THE COOLING PAD THAT WILL HELP HIM SLEEP THEY ARE 100,AND THE SCAHS SCHOOL FEE THAT I HAD TO PUT OUT WAS 425 DOLORS,WHILE I HAVE TO STAY HOME WITH HIM.AS YOU CAN SEE ,FROM THE PAST THINGS THAT HAVE HAPPEND.I THANK YOU A WORE OUT MOTHER REACHING OUT FOR A LITTLE HELP.MY NUMBER AND ADDRESS AGAIN IS ....TRACY LYNCH,MOTHER OF NOAH LYNCH.843-808-9525 306 CEDAR ST,UNIT 15 MYRTLE BEACH SC.29577
