I'm in the same place as I was a couple days ago. No need for us to lend weight to one approach over another at this point - especially since the House won't speak "definitively" on the budget until they slap their new amendment onto it early next week. Safe to remind them that we signed off on \$146 million for that last year. We'll monitor the conference committee process closely. We would be supporting of SUTA tax relief, but are especially eager to see the Senate act on H. 4996 and 4997, to offer broader, permanent tax relief for South Carolina's families and businesses.
