Congressman Joe Wilson contacted our agency on behalf of your husband, Donald E. Bailey, regarding eligibility for Medicaid's Nursing Home program.

We are pleased to inform you that Mr. Bailey was approved for the Nursing Home program effective March 1, 2009. You should receive his Medicaid card within 10 business days. You should also receive notice from your husband's eligibility worker, Torri Rogers, regarding the amount you are required to pay the nursing home for his care.

Ms. Rogers is aware that you became unemployed on July 31, 2009. Please notify Ms. Rogers when you begin receiving unemployment benefits as this will affect the cost of care.
