The Role of State Medicaid Directors

The Milbank Memorial Fund released a new study, the Role of State Medicaid Directors: A Leadership Imperative. This study was authored by Andy Allison, a former Kansas and Arkansas Medicaid Director. The study focuses on the current climate of Medicaid policy, organizations and leadership. There is a specific focus on how the administration is structured for Medicaid in the states and the adequacy of state investments in the role and compensation of these leaders. Medicaid is one of the largest federal programs and effective leadership of the program in each state is crucial.

What is Brain Health? Campaign

The Administration for Community Living (ACL) launched a campaign to promote information about the brain's changes over time and steps to keep the brain sharp. The campaign also offers tips for talking with loved ones and health care practitioners about symptoms if they arise. The Brain Health website is the anchor for this campaign. It houses tips and tools for promoting brain health, educational videos, links to social media, testimonials from real people, and an interactive feature that shows how the brain physically changes with age. Academy Award Winner Marcia Gay Harden also teamed with ACL to create a series of public service announcements to bring awareness to this issue.

Awardees Chosen for Chronic Disease Self-Management Education Programs

The Administration for Community Living's (ACL) Administration on Aging (AoA) awarded eight grantees with a two-year grant for chronic disease self-management education (CDSME) programs. These programs provide older adults and adults with disabilities with education and resources to assist them in managing chronic conditions like diabetes and heart disease. The grant recipients are: Health Foundation of South Florida, AgeOptions, Inc., MAC Incorporated, Mississippi State Department of Health, University of North Carolina at Asheville, Health Promotion Council of Southeastern Pennsylvania, Inc., South Dakota State University, and Community Council of Greater Dallas. ACL aims to reach about 25,000 older adults and adults with disabilities in underserved areas during this round of funding. Since 2010, nearly 250,000 participants have been supported under this grant. These programs are financed by the 2015 Public Health Prevention Fund, made possible by the Affordable Care Act.

Centers for Medicare & Medicaid Services

Applications Due for Oral Health Initiative Learning Collaborative

The Centers for Medicare & Medicaid Services' Oral Health Initiative is seeking applicants for their seven-month learning collaborative to provide state Medicaid agencies with technical assistance to develop and begin implementing oral health Performance Improvement Projects (PIPs). This application is open to state Medicaid programs and/or combined Medicaid/CHIP programs that are ready to develop, or are in the

process of developing, an oral health PIP. CMS will select three states to participate in this collaborative. Applications are due this **Monday, October 5, 2015**.

New Web Resource to Help Medicare-Eligible Employees

The Centers for Medicare & Medicaid (CMS) has released a new web resource to help Medicare-eligible employees understand Medicare and other retirement issues. It is important that individuals that are newly eligible for Medicare understand how and when to enroll, as well as the consequences of not enrolling. This knowledge will help to prevent gaps in insurance coverage or late enrollment penalties. This resource offers information about Medicare enrollment, how healthcare benefits are coordinated, the Health Insurance Marketplace, and Special Enrollment Period (SEP) eligibility. Employers may offer these resources to eligible employees for guidance on these issues.

Department of Health and Human Services

\$12 Million Cooperative Agreement to Expand Supportive Services to Holocaust Survivors

About 130,000 victims of Nazi persecution reside in the United States, and about 25% are impoverished. Effective service for this population requires special care to reduce the risk of re-traumatization. The U.S. Department of Health and Human Services (HHS) awarded a 5 year, \$12 million cooperative agreement to expand supportive services to Holocaust survivors in the United States. This agreement was awarded to the Jewish Federations of North America (JFNA) for up to \$2,467,500 per year, for up to five years. JFNA will contribute a 40% match. The goal is to achieve measurable outcomes in advancing innovations in the delivery of person-centered trauma-informed supportive services and improving the nation's overall capacity to provide services in this way.

HHS Sponsors Development of Drug for Hospitalized Flu Patients

The U.S. Department of Health and Human Services' (HHS) Office of the Assistant Secretary for Preparedness and Response (ASPR) is sponsoring the development of an experimental influenza antiviral drug. The ASPR Biomedical Advanced Research and Development Authority (BARDA) will provide technical assistance and funding of up to \$103.5 million to Janssen Pharmaceuticals. The existing flu drugs are most effective when taken within 48 hours of developing symptoms. According to research, most individuals are not hospitalized

within this period making the drugs less effective. HHS is hopeful that this drug will be more potent and have a longer treatment window than the existing drugs for influenza.

Wisconsin Assembly Committee on Aging & Long-Term Care

Wisconsin Sees Reduction in Falls and Improvement in Nutrition for Seniors

The Wisconsin Assembly Committee on Aging and Long-Term Care announced the findings from their review of the overall health of Wisconsin, with specific focus on senior health, during a 90 minute hearing on September 9, 2015. Wisconsin's rank in the *2014 America's HealthRankings Senior Report* rose from 10th to 7th in the 15th edition due to programs specifically engineered to reduce falls and improve nutrition for seniors. Tom Eckstein, *America's HealthRankings*; Chris Abbott, Health Plan CEO, UnitedHealthcare Medicaid and Retirement; David Lee, Executive Director, Feeding Wisconsin; and Otis Woods, Administrator for the Division of Quality Assurance, Wisconsin Department of Health Services, each spoke about what contributed to Wisconsin's low prevalence of falls and food insecurity during the hearing.
