This is in violation of the Common Law of the State of South Carolina.





At a Court of General Sessions, convened on **MAY 27 2014** the Grand Jurors of Greenville  
County present upon their oath:

That Perry Roy Eichor did in Greenville County, on or about the 20th day of March, 2014, by threat or force, intimidate or impede, or attempt to intimidate or impede L.S., a judge in the Municipal Court of Simpsonville, in the discharge of his duty to wit: implicitly threaten the future employment status of the judge as it related to his potential ruling in a matter pending before the judge. This act did destroy, impede or attempt to obstruct or impede the administration of justice in the Municipal Court. This is in violation of § 16-9-0340 of the South Carolina Code of Laws (1976) as amended.

**Perry Eichor Charged with Misconduct in Office, Obstruction of Justice,  
and Intimidation of a Court Official**

Thirteenth Circuit Solicitor Walt Wilkins' office confirms that PERRY ROY EICHOR, age 78, was charged today with Misconduct in Office, Obstruction of Justice, and Intimidation of a Court Official following an investigation by the State Law Enforcement Division. Solicitor Wilkins states that "Although it would be inappropriate for me to comment on the specifics of a pending criminal matter, I can confirm that Mr. Perry Eichor has been charged with one count each of Misconduct in Office, Obstruction of Justice, and Intimidation of a Court Official following a SLED investigation. As is customary, my office will be meeting with SLED investigators in the coming weeks to review the evidence in the case to determine what, if any, additional investigation is required."

The crimes of Misconduct in Office and Obstruction of Justice are common law misdemeanors that each carry a maximum penalty of up to ten years' incarceration, and the crime of Intimidation of a Court Official is a felony that carries a maximum penalty of up to ten years' incarceration or a fine of up to \$10,000.
