[Trump 'very close' to decision on Supreme Court pick](#) (*CNN*)

- President Donald Trump said Sunday afternoon he still had not made his final decision on a Supreme Court nominee, but anticipated finishing by Monday.
- "I'm very close to making a decision," Trump said. "Have not made it official yet, obviously. Have not made it final. But we're very close to making a decision."
- Before boarding Air Force One en route to Washington, Trump said he was considering four people and that of those under consideration, "you can't go wrong."

[Trump teases Supreme Court pick, vows 'exceptional person will be chosen'](#) (*Fox News*)

- "I'm very close to making a final decision. And I believe this person will do a great job," Trump told reports as he left for Washington from a weekend at his New Jersey golf club.
- When asked how many people were being considered, the president said: "Let's say it's the four people ... they're excellent, every one. You can't go wrong." Trump added that he would make his final decision "tonight or tomorrow sometime by 12 o'clock and we're all gonna be meeting at nine o'clock."
- The Trump administration has been preparing information materials on four potential nominees: appeals court judges Brett Kavanaugh, Raymond Kethledge, Amy Coney Barrett, and Thomas Hardiman.
- Sources who talked to Trump Sunday morning tell Fox News that the president's top two choices are Kavanaugh and Hardiman, though a GOP source said late Sunday that Barrett still has a good chance of being the pick.

#### [McConnell Tries to Nudge Trump Toward Two Supreme Court Options](#) (*NYT*)

- Senator Mitch McConnell, the Republican leader, told President Trump this past week that Judges Raymond M. Kethledge and Thomas M. Hardiman presented the fewest obvious obstacles to being confirmed to replace Justice Anthony M. Kennedy on the Supreme Court, according to Republican officials briefed on the conversation.
- While careful not to directly make the case for any would-be justice, Mr. McConnell made clear in multiple phone calls with Mr. Trump and the White House counsel, Donald F. McGahn II, that the lengthy paper trail of another top contender, Judge Brett M. Kavanaugh, would pose difficulties for his confirmation.

#### [Trump weighs top picks for Supreme Court amid last-minute maneuvering](#) (*Chicago Tribune*)

- President Donald Trump said he was "close" to choosing a Supreme Court nominee Sunday after a weekend at his New Jersey golf club evaluating four leading candidates and mulling the likely response of key senators and his core supporters to each prospect, according to White House officials and Trump advisers involved in the discussions.
- Over rounds of golf with friends, meals with family, and a flurry of phone calls and meetings with aides, Trump remained coy about his final decision, which is expected to be announced Monday evening from among the four federal judges atop his shortlist: Brett Kavanaugh, Thomas Hardiman, Raymond Kethledge and Amy Coney Barrett.
