When are state taxpayers responsible for expenses incurred by the governor's political travel?

The premise of the question misrepresents the issue. The State Ethics Act does not regulate "political travel", which seemingly could encompass all travel conducted one elected to political office. Rather, state law (Section 8-13-1346 of the South Carolina Code of Laws) prohibits use of public resources to influence the outcome of an election, which can better be described as campaign-related travel. Another state law (Proviso 117.76 of the General Appropriations Act) requires state law enforcement agencies to provide security detail to the governor at all times regardless of the purpose of the travel. Accordingly, Governor Haley initiated a Memorandum of Agreement with the State Ethics Commission and SLED to clarify when reimbursements are appropriate. Pursuant to the MOA, reimbursements are made for campaign-related events, which are defined to include but not be limited to campaign fundraisers, campaign rallies, and other events paid for and planned by the campaign. As also set forth by the MOA, the

Governor's staff shall determine whether an event is campaign-related, and the State Ethics Commission shall provide advice as needed.

Which state agency/agencies did the governor's office reimburse after a recent review of travel?

Pursuant to state law (Proviso 117.69), the Governor's security detail is provided by SLED, DPS State Highway Patrol, and DNR. Accordingly, reimbursements are made to these law enforcement agencies for costs, such as mileage, meals, accommodations, or airline tickets, incurred by the agencies for providing security to the Governor for campaign-related events.

For which trip(s) was/were this reimbursement related to?

Costs for all campaign-related events are reimbursed to the respective law enforcement agency. \*I assume that a reporter can match up the dates to the calendar to see a listing of events, and therefore, we do not need to provide.

Why was this trip reimbursed and not others?

Costs for non-campaign-related events are not reimbursed.
