Having that conversation with your family is critical to make sure they know what you want done when you can’t speak for yourself.

April 16 is Health Care Decisions Day. In recognition of that, the S.C. Bar Pro Bono Program and the S.C. Bar Elder Law Committee are partnering to provide an opportunity to get a health care power of attorney and living will completed and executed free of charge. Volunteer lawyers will be at Brookland Baptist Church from 10:00 am to 4:00 pm on April 16 to help individuals execute those documents.

There is no cost for individuals to do this. Pre-registration is not required; participants will be seen in the order they come in. There will be several attorneys working in 2 hour shifts and law students to help with registration.
