#### **BACKGROUND INFORMATION:**

- S.1189 was signed on June 2, 2014
- Passed unanimously: Senate 42-0 House 105-0
- Key points - S.1189:
  - Distributed Renewable Energy (DER) Program – (tied to new net-metering)
  - Sets new /updated net-metering rates
  - Enables leasing of solar panels – residential and commercial
- The South Carolina Public Services Commission (PSC) is charged with implementing the new law.
- S.1189 is a balanced compromise bill developed by electric cooperative, utilities providers, solar power proponents and conservationist to create and protect customer choice in buying solar, provide flexibility that works with utilities' business models, institutes opportunity for leasing companies and sets improvements to net metering rates.
- This is the second significant piece of clean energy legislation signed this year - H.3125 also known as the Clean Energy Industry Manufacturing Market Development Advisory Commission – which is to assist in developing clean energy technology, materials, and products in this state.

#### **SUGGESTED TALKING POINTS:**

- This bill I'm signing today passed the General Assembly in a unanimous fashion.
- The "Solar Energy Bill" opens the way for more distributed energy production in South Carolina. Provides producers and consumers of electricity with more choices and moves solar power forward.
- Today is a shining example of a collaborative effort among a diverse group - electric cooperatives, utility providers, environmental groups, business groups, and consumer advocates. It's truly a win-win for South Carolina.
- I'd also like to recognize Senator Greg Gregory for his leadership on this bill. He was instrumental in getting all sides on board.
- While costs of solar panels have declined recently, they are still too expensive for many people and businesses to purchase.
- In addition, South Carolina law placed obstacles in the way of solar energy expansion by blocking the leasing of solar equipment and not offering attractive terms for selling excess energy back to the grid.
- This important bill changes that. Now consumers and businesses are given the freedom to lease solar panels without shouldering the high upfront cost of solar panels. This simple change will expand choice in the types of energy individuals and consumers can use to meet their demands.
- Likewise, the bill ensures those who generate solar electricity receive a fairer price from utilities for the solar power sold back to the grid.
- Over the last couple years, both sides voiced their concerns and were eventually able to broker a compromise that, while not perfect, is acceptable to all the stakeholders involved.
