O, Myra in Jundaburk need help! My
Yatey... eight year old daughter, Kimberly
S. Yost was diagnosed with Systemic
Lupus after having a stroke in the
early twenties. She recovered and returned
to work. To prevent more strokes she
was prescribed strong doses of Coumadin.

In 2001 she had Hemoragel so much
that her Hemoglobin was 3. She was given
eleven units of blood. And had a hysterectomy.
After a long ^{long} she returned to work.
Her dream was to have her own Child
Care Center. She attended York Technical
Center and earned a Child Care Certificate.
But Lupus made that an impossible dream.
My youngest daughter Susan S. Broughton
is an R.N. Kim went back to York
Tech to be a L.P.N. She went to
school at night so that she could keep
her job.

October 15, 2014 she became very
ill with stomach cramps. She was
admitted to Spring Memorial Hospital.
The one organ that was left was

Hemorrhaging. She had to have fourteen units of blood. She stopped breathing the night after the surgery. She was in a coma for two weeks. During that time she had numerous strokes and seizures. She was in Springs Hospital for two weeks and then was transported to CMC main in Charlotte. She stayed there for twelve days. When Kim woke up she could not walk, talk, hear or speak. After numerous therapies she returned to work in May 2005.

- Kim should not work, but she and her husband Jerry had a girl in middle school. Due to Jerry's drugs, alcohol, adultery and unemployment they divorced in 2006. Kim's father, my husband, Keith W. Starks ^{deceased} after a stroke complications of Sept 1997. Keith was a Senior Leptine Analyst for Springs Global. Kim has not been able to work since May 2014. Father Dr. Kimbell or Mr. Barak will allow her to work --- She cannot work. I need help! I thought that I had enough in a retirement account to manage. I retired in 2006. - School teacher. I am Kim's sole support, most of my

money is gone.

Please help me. No one in
our family has ever been on
disability. I do not understand
why it is so ~~so~~ complicated.

To whom it may concern:

Ms. Yost has been a patient in my Rheumatology practice since January, 2001 and was first seen here as far back as August 1992. She suffers from a particularly pernicious form of Systemic Lupus associated with anti-phospholipid antibodies and recurring thromboembolic events. In 2003 or 2004 she suffered a sagittal sinus thrombosis resulting in post anoxic encephalopathy. In spite of this, she continued to work for a time as a child care worker but she never regained full cognitive function or communication skills. She has been maintained on Coumadin ever since her thrombotic episode in order to prevent additional thromboembolic events. She also must take two different anti-seizure medications to prevent recurring seizure activity.

During the latter part of 2011 or early 2012, she developed an aggressive inflammatory polyarthritis which greatly limited her ability to lift, carry, climb, stoop, or walk. She was no longer able to continue working as a child care worker. She had to stop working May 8, 2014. Her arthritis was unresponsive to weekly Methotrexate and low doses of prednisone up to 20 mg daily. Ultimately, she did improve after being started on IV Benlysta in 2014 but not to a level where she could return to work.

Ms. Yost is in no way capable of returning to any form of daily work due to her multiple health issues.

PLEASE CALL OUR OFFICE IMMEDIATELY UNDER THE FOLLOWING CIRCUMSTANCES:

- ★ If you have a change of name, address, or phone number
- ★ If you are hospitalized
- ★ If you have a serious change in your medical condition or if you are diagnosed with a new condition
- ★ If you return to work
- ★ If you receive a notice scheduling your hearing, a Notice of Reconsideration or any other communication from the Social Security Administration that indicates that you have a deadline
- ★ If you are incarcerated or if you have an outstanding warrant for your arrest
- ★ If you have a Workers' Compensation case that settles
- ★ If you have a mortgage on your home and you receive a Notice of Foreclosure
- ★ If you are receiving unemployment compensation

OTHER IMPORTANT THINGS TO REMEMBER:

- ★ Please keep us updated as to your medical treatment by either completing and returning the enclosed Medical Update forms and returning them to us by mail or by calling your paralegal regularly to inform her of the medical providers that you are seeing.
- ★ DO NOT CALL THE HEARING OFFICE TO CHECK ON THE STATUS OF YOUR CASE. If you would like an update, please call your paralegal.
- ★ All calls are routed through the paralegals. If you need to speak with an attorney, please call your paralegal and request that she schedule you for a telephone conference with the attorney.

TIME FRAME

If the next step is for us to file a Request for Reconsideration in your claim, it will likely be 6-9 months before we receive another decision. If you receive a call from Disability Determination Services requesting information about your daily activities or medical providers, please give that information to the disability examiner. There is nothing that we can do to decrease your wait time – other than supply information as requested.

Because of the tremendous backlog of Social Security Disability cases awaiting hearings before Administrative Law Judges, the average wait time from the date that the hearing is requested until the date that the hearing is scheduled is approximately 13-18 months – depending on your hearing office location. There are only a few things that can result in a hearing occurring earlier. These generally include being diagnosed with a condition or with a change in condition that is likely to result in death within 6 months or homelessness. If either of these occurs, please contact our office immediately so that we may alert the Social Security Administration.

In some cases, a hearing may be scheduled a little sooner if a United States Senator or Representative makes an inquiry on your behalf. Please be aware that members of Congress are much more likely to make an inquiry on your behalf if you are a registered voter. Included in this folder are contact information for United States Senators and Representatives and a voter registration form. Representatives vary by district. Please consult the information provided in this folder to determine who represents your Congressional District.
