I am sorry I had not yet gotten back to this. With school starting this week has been very busy. Until the new report card comes out in November here are places where you may find the current data available. Please take a look and then let me know if you need this further broken down by district and I can submit a data request for you.

It does just list students with disabilities and depending on the number of students we may or may not be able to break that down by disability. When the number falls too low we cannot produce it as it could lead to someone figuring out which student it is. (for example if there is a school of 400 and only 5 students are classified as autistic one could easily

determine who those students were at the school)

Here is the information on dual enrollment and this also shows by district pupils in poverty (not called free and reduced anymore), Limited English Proficiency, etc.
