Thank you for your third (3rd) FOIA regarding this provider. Below are the responses that correspond to your bullets:

- As far as I can tell, we have not yet received the final Alliant report related to Willowglen.
- We believe that the FY 10 and 11 Contract Compliance and Licensing Reviews were included in the information previously provided. They would have been in close proximity to the e-mail from Ms. Dalton. Let us know if you would like us to re-copy these.
- We are still looking, but so far, have not found any additional communication between SCDDHHS and SCDDSN during the past three years, other than what was contained in the files provided to you previously.
- We are still looking, but enclosed is the additional correspondence we have found so far between SCDDHHS and the Attorney General's Office related to Willowglen over the past 3 years.
- We are still looking, but enclosed is the additional correspondence found so far between SCDDHHS and SCSSS regarding Willowglen.
- Other than what was previously provided to you, there are no documents that reflect the listing of every component of all the inclusive daily PRTF rates. We do have a large notebook that has additional documents related to PRTFs, but we want to reiterate that only the documents provided to you were used to determine the rates. If you would like to look at the whole notebook, please contact us to arrange a time.
- Enclosed are the Chronological Listings of Significant Case Actions on the providers you listed.
