




Biography – Sam Hamad – Minister of Economic Development, Innovation and Export Trade, Government of Quebec

An Engineer by trade, Sam Hamad also holds a masters degree in Civil Engineering and a masters in Management. Before entering politics in 2003, he was Senior Vice President at Roche Ltd, an engineering consulting firm. He was also a Lecturer in Management at Laval University.

Passionate about business, he has been President of the Board of Trade and Industry of the Metropolitan Quebec and Vice President of the Fédération des Chambres de commerce du Québec.

Recognized for community involvement, Mr. Hamad has been Chair of the Board of Directors for the Fondation de l'Auberivière (1990-1993), Chair of the Board of Directors for the Conseil régional de l'environnement Chaudière-Appalaches (1993-1994), member (1994-2001) and Vice President of Centraide-Québec (1999-2001), President of the Forum Énergie de la Capitale (1995-1999), member of the Board of Directors for the Fondation de l'Hôpital Laval (1998-2000), member of the Capital-Québec Committee (2000-2001), chair of the working group for the renewal of the Québec public service (2001-2002) and President of the Québec/Chaudière-Appalaches chapter of the Ordre des ingénieurs du Québec.

He's the MNA for Louis-Hébert since 2003, he has successively been Minister of Natural Resources, Wildlife and Parks, Minister of Employment and Social Solidarity, Minister of Labour and Minister of Transportation.






Agribusiness includes over 200,000 jobs statewide and is growing. Every \$1 invested yields \$132.00 in economic impact. Every \$1 invested also creates \$11.80 in new tax revenues.

Agribusiness is a crucial component of South Carolina's economy and from my time in the legislature until now, I know that without farmers South Carolina would not be what it is. In many of our rural counties, agribusiness offers a bright future for our farmers and for those who are currently unemployed – mixing industry with South Carolina's rich tradition in agriculture.

BACKGROUND:

The Southern Association of State Departments of Agriculture (SASDA) is one of four regional organizations affiliated with the National Association of State Departments of Agriculture (NASDA). NASDA is based in Washington, DC.

SASDA consists of 15 southern states, Puerto Rico and the Virgin Islands. The organization's mission is to represent, support, and develop solutions for agricultural issues affecting the southern region of the United States. In addition, the organization supports economic development initiatives in rural and urban areas of the SASDA region creating opportunities for growth and expansion of agribusiness.

On behalf of the state of South Carolina, it's great to be here with you today.

It's exciting to be here with you for this celebration for Nexans. We thank Stephen Hall, Frédéric Michelland and Nexans as a whole for choosing to do business in South Carolina.

When companies choose to invest in South Carolina, it is an important sign that we are doing the right things on the economic development front to attract new investment and jobs.

With our business friendly climate and skilled workforce, we were able to recruit 20,013 new jobs and over \$5.12 billion in investment last year.

- Recruited a near-record in new jobs for the year

1. Why is it important to South Carolina that Nexans has chosen this location for its plant?
  - We are always excited when a firm decides to create a presence in S.C. Nexans also strengthens the status of S.C. as a home for international companies.
  - Foreign-affiliated companies have invested \$41.1 billion in the state. Foreign-affiliated companies have created more than 158,800 jobs over the years. South Carolina has more than 1,200 operations of foreign-affiliated companies.
  - We look forward to Nexans prospering and growing in our state.
  
2. Nexans is looking to hire over 200 new employees for this plant. What does that mean to the population of Berkeley County?
  - We celebrate 200 new jobs anywhere in the state; that's a sizeable job creation commitment. It will certainly be important to the people in Berkeley County in bringing more employment to the area.
  - At \$85 million and 200 new jobs, it's certainly one of the larger announcements in Berkeley County in the last few years.
  
3. Why do you believe global companies are choosing to grow in South Carolina?
  - South Carolina has a lot of advantages. We keep the costs of doing business low and don't have an onerous regulatory environment.
  - Our workforce is top-notch. We have some of the best worker training programs in the country. S.C. also has one of the lowest unionization rates in the country.
  - We also have the advantage of one of the busiest ports on the East Coast in Charleston. Our central location between New York and Miami also provides access to markets all across the Southeast and East Coast.
  
4. What tools are you using to attracting new businesses and manufacturers to this region?
  - It starts with a business-friendly climate. We are constantly striving to give companies and environment where they feel they can be successful. We work hard to keep business costs low, whether it be in the arena of taxes or regulation.
  - Our Commerce department does a great job of selling the state, as do the local and regional economic developers. They all have a strong commitment to teamwork and helping businesses find the right place to locate.
  - o S.C. Commerce also has international offices in Europe and Asia that work with businesses interested in establishing or expanding operations in North America

– and persuading them that the Palmetto State is the place to be.

5. Historically, South Carolina has been considered a major player in the textile industry. In the last couple decades, the state has switched its focus in the manufacturing sector to include industries like automotive, aerospace and now High Voltage cable. What does the diversification of manufacturing mean for the state's economy?
  - South Carolinians have always known how to make things. That we have the ability to make a number of different things makes our economy stronger.

  - Our technical college system does a great job in preparing workers because it engages with the business community to help determine their needs. This is important to manufacturers of all sizes.
  
7. How do the technical, and higher education opportunities stack up do compared with other states?
  - With 12 public four-year colleges and universities, 22 private colleges, and 16 technical colleges, South Carolina offers a host of opportunities to its residents for higher education and specialized technical training.
  - Home to three world-class research universities: Clemson, USC and MUSC.
  - The number of STEM associate, baccalaureate and doctoral degrees awarded in South Carolina has increased by 25 percent in the last decade.
  
8. Where is South Carolina on the measurement scale for cost of living compared with the rest of the nation for working families who want to relocate here?
  - In South Carolina, only 88% of the average national cost is required to maintain the same standard of living. The cost of living index for South Carolina is 0.88, where the United States is 1.0. A family's dollar stretches a lot further in the Palmetto State than it does in other parts of the country.

BIO OF VIJAY AMRITRAJ

Born December 14, 1953, in Madras, India, is a former tennis champion and actor.

Vijay Amritraj and his brothers, Anand Amritraj and Ashok Amritraj, were among the first Indians to play in top-flight international tour tennis. In 1976, the brothers (Vijay and Anand) were semi-finalists in the Wimbledon men's doubles.

Playing his first grand prix event in 1970, Amritraj achieved his first significant success in singles in 1973 when he reached the quarter-final stage at two Grand Slam events. At Wimbledon he lost 5-7 in the fifth set to the eventual champion Jan Kodes and later that summer at the U.S. Open lost to tennis great Ken Rosewall after having beaten another legend, Rod Laver, two rounds earlier.

Amritraj repeated his feat at Forest Hills in 1974 when he went out in the last eight again to Rosewall after beating a young Björn Borg in the second round. In the years that followed he reached the latter stages of numerous Grand Prix events but failed to meet with success in the grand slams. It would not be again until 1981 when Amritraj would again proceed to the quarter-finals, going out in five sets to Jimmy Connors. This match typified Amritraj's tennis. He was a natural grass-court player who liked to chip-and-charge, and serve-and-volley. He could compete against the world's best but often would lose longer matches through a lack of stamina. Against Connors he was up two sets but lost the last two convincingly in a 6-2, 7-5, 4-6, 3-6, 2-6 loss. A similar Wimbledon result occurred in 1979 in the 2nd round where he looked set to defeat defending champion Borg, up two sets to one and 4-1 in the 4th set, only to lose 6-2, 4-6, 6-4, 6-7, 2-6.

Amritraj was the captain of the Indian Davis Cup for much of the late 1970's and 1980's, helping India reach the finals in 1974 and 1987. It was here that he revelled as a champion and chalked memorable wins against higher ranked players. A do-or-die five set epic over Martin Jaite was the highlight of India's run to the final in 1987. He compiled a career singles win-lose record 384-296, winning 16 singles titles to go along with 13 in doubles. He beat the best, including John McEnroe at his peak in 1984 (in the first round in Cincinnati) and had five career wins over Connors in their 11 matches. He reached his career high ranking in singles of World No. 16 in July, 1980.

Vijay also had a brief acting career, appearing with Roger Moore in the James Bond film, Octopussy as Vijay and in Star Trek IV: The Voyage Home. He has since gone on to become a sports commentator, has been a judge at the Miss Universe pageant, and has developed a successful multimedia business.

Both his son Prakash Amritraj and nephew, Stephen Amritraj are professional tennis players.

**SUGGESTED TALKING POINTS:**

Meeting Street Academy opened in 2008 with 45 students and now educates 112 through the second grade.

This is a ribbon cutting for the new location built to house the expanding population.

MSA indicates that it costs around \$12,500 to educate each pupil annually, but only charges \$2/day for tuition and \$1/day for after care.

Testing indicates that the majority of MSA's pupils in pre-K programs place above national averages going into the first grade, with none currently falling in the lowest quartile.

This type of partnership shows that students can succeed if we let communities and private citizens work outside of our normal bureaucracies and focus on child success.

I frequently say that South Carolina spends plenty of money on education, we just don't spend it the right way and the Meeting Street Academy is an excellent example of that. While Meeting Street's Students cost about the same as any other South Carolina student, the difference is staggering.

- There is an emphasis on reading and mathematics that does not interfere with fine arts education. Instead, they augment each other and lead to student success.
- You have high-quality administrators, but your administrative costs are low – you send more money to the classroom and that's where you get your dividends on education.
- Students spend more time at school, but they also spend a significant amount of time out-of-school learning how their knowledge is applied in the world.

In addition to education, Meeting Street understands that healthy children come to school, and that's why medical screenings are provided to students. Now compare what you get here at Meeting Street to a South Carolina child in a public school many of whom are on Medicaid, many of whom are receiving services through First Steps, and all the results aren't even close.

We need to bring this sort of innovation to our education system in South Carolina, holding districts accountable for how they perform, giving parents the ability to break away from local schools that are failing them, and telling administrators of failing

schools and districts that if they don't shape up, we will ship them out.

I'm so excited that I have had the opportunity to be here today and I wish the students of Meeting Street Academy here in Charleston, and those new students in Spartanburg the best of success.

Founded in 2008 in Charleston, South Carolina, Meeting Street Academy provides a first-class, college preparatory education for families who care deeply about education but cannot afford traditional private schools. We offer an education that starts early with children at age three, recognizes the important role that parents play through intentional partnerships, and focuses on meeting the needs of the whole child.

Our goal is to ensure that all children receive an excellent education that prepares them to excel in the best middle and high schools, gain entrance to great colleges and universities, and enter the workforce as productive contributors to society. MAY, 2006

A small group of Charleston citizens began to ponder the need for a school that would provide a high quality college preparatory education to students who were assigned to failing public schools in our city. MSA was created as a result of the belief that a child's zip code should not determine his or her educational opportunities.

January, 2008

MSA's founders met with Mayor Joseph P. Riley to discuss the concept of Meeting Street Academy. Mayor Riley was so inspired by the school's premise and the founder's generosity that he began working to secure a site for MSA-Charleston's future flagship school.

June, 2008

Patricia Scarry M.Ed. was named as the first Director of Meeting Street Academy. With a background of 14 years of education experience specializing in early childhood literacy, Ms. Scarry had most recently served as director of the Child and Family Development Center in North Charleston; an NAEYC accredited Family Literacy Program.

August, 2008

MSA-Charleston opened its doors in a temporary location, 1156 King Street, to forty-five preschoolers, ages three and four.

The City of Charleston generously leased/donated land at 642 Meeting Street (corner of Meeting and Cool Blow Streets) for the future site of MSA-Charleston's flagship school.

May, 2010

MSA-Charleston graduated its first kindergarten class. All students entered first grade with the ability to read grade-level and above grade-level texts.

August, 2010

South Carolina Gubernatorial Candidate Nikki Haley, who was elected Governor in November 2010, visited MSA-Charleston and launched the education platform of her campaign from our site.

December, 2010

Shortly thereafter, it was announced that MSA-Spartanburg would open its doors in July 2012.

Groundbreaking at the future site of MSA-Charleston's flagship school at 642 Meeting Street, with Mayor Joseph P. Riley serving as Master of Ceremonies. Completion expected for the 2012 – 2013 school year.

June, 2011

Susan Miller, M.Ed. relocated from Cincinnati, OH to become MSA's first Chief Operating Officer. With a solid foundation of 22 years' experience in various facets of education, Susan most recently served for 9 years as a principal of Cincinnati Hills Christian Academy, a highly successful PK-12 school with an enrollment of 1,520 students.

June, 2011

U.S. Congressman Tim Scott visited MSA-Charleston and inspired our students with the story of his upbringing under circumstances similar to those faced by many of our MSA families. Congressman Scott stressed the critical importance of education on the path to becoming a leader in the community.

July, 2011

MSA elected to move to a year round calendar to better meet the needs of the students served.

Today

MSA-Charleston is home to 112 students ranging in age from three year olds through third grade. We are expanding by one grade each year as our students advance, with the goal of eventually serving students through the fifth grade.

July 2012 marks the 20th year of the NG state partnership program – a program designed to maintain international relationships and improve the readiness of partner nations in areas from homeland security, to emergency preparedness, to combat operations.

South Carolina's partnership with Colombia is the 64th partnership in the program, and one of 22 currently active.

Colombia's Ministry of Defense first expressed interest in a partnership in April 2011, and we have been working to develop the partnership since.

This represents a step forward in international cooperation between the US and our neighbors to the south. While there is real opportunity to improve efforts to pool our collective expertise to curb drug trafficking, there are other real opportunities for our two nations to share expertise in disaster preparedness, homeland security operations, and military operation.

We have seen the North Dakota National Guard train Ghana's military in disaster management, the Maryland National Guard train with Bosnian forces to increase preparedness, now South Carolina has an opportunity to join a partnership that will make both Colombia, South America and Columbia, South Carolina safer places to live.

This partnership isn't just about building stronger forces; it's about building stronger relationships between militaries and nations. Our uniforms may look different, and our languages may be different, but citizens who choose to serve their countries are there to build stronger communities and safer nations for their families – our goals are the

same.

This allows a level of familiarity and understanding between forces and nations. The great thing about this partnership is that Colombian soldiers are getting to know South Carolina through some of the best representatives we can send – our soldiers, and South Carolina gets the same opportunity. It's a great thing.

**BACKGROUND PROVIDED BY SOUTH CAROLINA NATIONAL GUARD:**

PLEASE NOTE: Avoid any suggestion that the SPP is a formal defense agreement. In fact, it would be best not to say the word agreement at all. Rather, SPP is a partnership involving the National Guard of a state and a country (in this case, South Carolina and Colombia) in which both partners learn from one another to effectively demonstrate humanitarian values, enable interoperability, and promote military support and subordination to civil authorities.

- This month, July 2012, marks the 20<sup>th</sup> anniversary for the National Guard's State Partnership Program.

- The State Partnership between South Carolina and Colombia is the 64<sup>th</sup> State Partnership in the program's 20 year history. Today (with Colombia) there are a total of 22 SPP relationships with 28 countries in USSOUTHCOM's area of responsibility.

-Overview: The program's goals reflect an evolving international affairs mission for the National Guard to interact with both the active and reserve forces of foreign nations, interagency partners, and non-governmental organizations, emphasizing the National Guard's unique state and federal role. SPP is a partnership of equal partners and as well as one of shared responsibilities in addressing transnational concerns.

-Program partners engage in a broad range of security cooperation activities to include host nation defense/security, disaster response/mitigation, consequence/crisis management, interagency border/port/aviation security, combat medical, fellowship-style internships, and bilateral field events that lead to training and exercise opportunities. Activities are coordinated through Combatant Commanders, U.S. Ambassadors' country teams, and other agencies as appropriate to ensure cooperation is tailored to meet U.S. and international partners' objectives.

- SPP events involve small teams of subject matter experts sharing and learning from one another.

-SPP promotes a "Whole-of-Government" approach, particularly in areas such as disaster response that require close coordination with various government agencies involved in emergency response management.

-SPP is a model for security cooperation in the 21st century, an integral component of the national defense strategy.

-SPP is an innovative DoD joint security cooperation program, managed by the National Guard and executed by the State Adjutants General in support of Combatant Commanders security cooperation objectives and Ambassador Country Plans under the authorities provided by the DoD and Congress.

-Under the National Guard SPP, the National Guard conducts high-impact, low-cost tailored security engagements with a small footprint in their partner countries that establishes long term enduring security cooperation relationships with US friends and allies around the world. These relationships create strategic access for key stakeholders and can be leveraged for broader activities such as civilian engagements, ANG/ARNG international engagements and peacekeeping missions.

-The State Partnership Program is experiencing an increase in visibility and attention since DoD published new Defense Security Guidance and military leaders look to develop low-cost soft-power options focused on shaping the security landscape. SPP is one of six partnership

COLOMBIA SPECIFIC TALKING POINTS:

- The Colombia Ministry of Defense expressed interest in joining the SPP in April 2011; their request was staffed through the U.S. Ambassador, the Combatant Commander, and the National Guard Bureau.

- Colombia has maintained an excellent relationship with the U.S. for many years and looks forward to joining the SPP. We will encourage the Colombians to bring their much needed value added for the U.S. in this partnership, especially with the Colombian Armed Forces experience, which is recognized as elite and experienced in jungle forces special operations.

Stephen Grant, a member of the Gateway House Board, was recently named by Northwestern Mutual Life as one of their 20 recipients nationally to receive a "Community Service Award" for volunteer efforts with Gateway House. On July 24 in Milwaukee, Mr. Grant received a check for \$10,00 from Northwestern Mutual's Foundation for the Gateway House. Previously, when Mr. Grant received the award, Congressman Bob Inglis presented the check.

Steve Grant has served on the Gateway House board of directors for twenty-two years. Steve has been a leader as well as a mentor for staff and other board members. Steve has worked tirelessly to help improve the quality of life for mentally ill adults not just in Greenville, South Carolina but also around the world. Since joining the board in 1990, Steve has helped grow Gateway House to become a Clubhouse Model Rehabilitation Program that is recognized internationally.

1. On an annual basis, Gateway House serves over 250 seriously mentally ill adults.
2. On a daily basis, Gateway House provides services to 80-90 men and women who are living with a chronic mental illness.
3. When Gateway House first started in 1984, approximately 90% of the members lived in costly residential care facilities. Today, almost 90% of the members live independently in their own apartment.
4. The national unemployment rate for the seriously mentally ill is 90% compared to 50% for the participants at Gateway House.
5. With the training and support from Gateway House, 23 of the 80-90 members who attend each day, work on transitional employment positions with local businesses such as MetLife, Furman University, Schlotzsky's Deli, and TJ Maxx. In addition, 26 active members are supported on their own independent job.
6. Gateway House owns and leases 72 apartments to Gateway House members who are interested in living independently.
7. Prior to moving into a supported apartment at Gateway House, almost 100% of the residents were either homeless or at risk of becoming homeless.
8. Gateway House is extremely effective reducing inpatient psychiatric hospitalization rates and emergency room visits.
9. Since July 1988, Gateway House has been an international training base for the Clubhouse Model of Psychiatric Rehabilitation. Since that time, Gateway House has trained over 2,000 colleagues from 16 foreign countries and 40 states in the US.

**BACKGROUND:**

Gateway House is a private, not-for-profit, clubhouse model rehabilitation program for men and women in Greenville County suffering from mental illness. Modeled after Fountain House in New York City, the nation's first clubhouse-model program, Gateway House has been providing a permanent support system for persons with mental illness in upstate South Carolina since 1984. In 1988, due to the outstanding quality of its programs, Gateway House was selected by Fountain House in New York City to be one of five national training centers in the Clubhouse Model of Psychiatric Rehabilitation. Since that time, over 2,000 colleagues from 40 states and 14 foreign countries have participated in training at Gateway House.

History

1983

Community Planning Council and the United Way of Greenville County conducts a community-wide Needs Assessment Planning Study. Results show a need for day services and housing for the seriously mentally ill in Greenville County. Mental Health Association adopts needs-assessment and develops a task force to address the problem.

Task force forms 501©3 corporation with mission of improving the quality of life for the mentally ill in Greenville.

1984

Gateway House Board hires Phil Emory as executive director to implement a clubhouse model rehabilitation program modeled after Fountain House in New York City, the oldest and most effective psychiatric rehabilitation program in the United States.

Gateway House begins operation two days a week in one small room at Earle Street Baptist Church.

1985

Gateway House completes renovation on clubhouse at 415 Rutherford Street.

1986

Gateway House purchases second house adjacent to clubhouse.

Gateway House purchases Earle Street Apartments.

Gateway House and the Greenville Alliance for the mentally ill receive HUD funding to build Portals, the first HUD project for persons with mental illness in South Carolina.

1988

Gateway House selected as a Training Base in the clubhouse model of psychiatric rehabilitation

1991
