Re: Governor Nikki Haley had knowledge and played a significant role in facilitating the Nuclear Power Facilities Cyber Security Cover-Up because Dr. Vincent van Brunt and Stephen Byrne, both members of South Carolina's Nuclear Advisory Council were well aware of the inability to cyber secure the nuclear facilities and the design of the human resources mechanism related to the design and construction of the nuclear facilities does not have the integrity to eliminate and insure the possibility of terrorists infiltrating the nuclear power industry. There could be terrorists already embedded in the nuclear industry.

Swati Patel, Chief of Staff:

First of all, the Charlotte Office of the United States Federal Bureau of Investigation and I have established a dialogue regarding this matter. Special Agent in Charge, John Strong and the legal counsel of the Charlotte office has detailed knowledge of this matter.

During 2012 Dr. Vincent van Brunt of South Carolina's Nuclear Advisory Council came to the Lexington County Detention Center specifically for the purpose of speaking with me technically regarding cyber securing the nuclear power facilities which I had previously proven was going to be impossible to cyber secure the control systems as well as preventing a terrorist element from infiltrating any or all of nuclear. I am hacker who was released from federal prison the first I served a federal sentence and was able to be hired as a senior level electrical engineer designing nuclear power facility's electrical and control systems. No formal technical training and no degree of any type. Shaw Nuclear of the Shaw Group was under the impression I possessed an advanced technical degree when in reality my IQ was more than 150.

Read the story. All documents which will support this story are enclosed and can be very easily authenticated.

Nuclear Cyber Security Cover-Up
(a synopsis)

During 2007 my curiosity had gotten the best of me. I had already hacked the exact same systems which were being planned to be installed in the nuclear power plants and I had to find out if the nuclear industry had developed some new magical way of cyber securing the nuclear power plants. So I applied for an engineering position at Shaw Nuclear. I was recently released from federal prison where I had served a sentence for a computer related crime. I possessed the technical ability to digitally infiltrate any database, including the feds systems. I have no degree of any type and I have never been enrolled in any formal technical class ever. I had been blessed with a technical aptitude well into the genius range.

Within 5 minutes of being interviewed by Keith Bush, PE (professional engineer), the assistant chief electrical engineer, I was offered a senior level electrical engineering position which entailed designing the computerized control systems for the nuclear power plants, including the actual nuclear reactors. Within about 3-4 months I had taken on the responsibility of instructing the actual engineers who actually possessed real BS, MS and PhDs in electrical engineering. This included the electrical, instruments & controls, mechanical and chemical disciplines of engineering. The core of my curriculum was 'how to design nuclear power plants'. There were numerous engineers there that literally did not know what nuclear power plants were. They had no idea that nuclear power plants produced electricity.

On numerous occasions I would use my Shaw Nuclear issued corporate American Express card and fly to Pittsburgh where I would rent a vehicle and drive to the Westinghouse Nuclear Corporation who was one of the partners and owners of the AP1000 nuclear reactor. After easily getting by security because I possessed all the proper Shaw Nuclear identification I would go to the basement level of their facility where I was allowed unimpeded and unescorted access to multiple 'up and running' DCS (distributed control system) which I needed no password. These systems were the exact same systems which would be controlling at least 8 nuclear reactors. I AM NOT A TERRORIST, but if I was this would have been an opportunity to embed an undetectable viral algorithm into the systems which could have caused 8 nuclear meltdowns on the exact same day, hour, minute and second. South Carolina's VC Summer Nuclear Station of Jenkinsville, SC had 2 systems among them as well as Plant Vogtle of Waynesboro, GA which is juxta positioned to the SC border.

After being employed by Shaw Nuclear for nearly 2 years I approached Dave Barry who was the president of the nuclear division and began telling him of numerous ways of hacking these systems and explained these systems could never ever be cyber secured. Also I explained that technology was advancing in such a rapid manner that by the time we put these reactors on-line with the power grid, which is about 12 years from the start of the design phase to the end of construction, that these control systems would be so old that they could be hacked by the latest model Xbox or PlayStation of that time. An unfixable technological paradox and they (7 Fortune 500 Corps) were at least \$40,000,000,000 into multiple projects.

I then dropped the proverbial 'nuclear bomb' on him. I revealed that I was a federally convicted felon/hacker that only possessed a high school diploma. No bachelors, no masters, no PhD in electrical engineering. They were under the impression that I possessed a PhD or at least a masters in electrical engineering because I was successfully instructing their real engineers.

There's a saying: "If you're going to be a monkey, be a gorilla".

Don't be a spider monkey, don't be a gibbon's monkey, don't be a chimp or a baboon nor an orangutan but be a silver back King Kong. If you're going to fake it, fake the highest position possible. I was successfully instructing their best technical personnel.

I was asked to keep this to myself and within 24 hours I was offered an extra 100k per year under the table to keep quiet. I would not accept and within weeks I was terminated for allegedly offering a female a position at Shaw Nuclear in return for sex. It was a setup. The female coincidentally was the daughter of one of Shaw's top execs best friend.....

.....and the "Nuclear Power Plant Cyber Security Cover-Up" began.

Shaw's management soon discovered that I had been writing a tell-all manuscript which I intended to title "Cocaine, Kickback\$ & Nuclear Plants" and I had a stock pile of nuclear documents ranging from nuclear design drawings to nuclear power plants design specifications. At that point I was offered 500k and I refused their offer because this needed to be told. I knew they were desperate and would have me

killed in order to keep this from going public so I went to WBTV of Charlotte and did an on-camera interview with their anchor, Jamie Boll. Then I immediately informed Shaw Nuclear's management of the existence of the interview and if anything would happen to me my family would get the footage and raise hell. This keep me alive. The footage is still there.

Later an attempt to blackmail me after a local female came to my home and took a nude picture of me using her cell phone without my knowledge. Two days after she took the picture Shaw was using the photo in an attempt for me to take 900k. I wouldn't accept. The female, Melba Carter, admitted on a Chester County Sheriff's report that she took the photo in my home without my knowledge. A criminal act which Shaw made sure she was never prosecuted for. Melba Carter filed a Chester County Sheriff's report where she admitted to taking the photo in my home without my knowledge. Sheriff's report enclosed.

Shaw then told the FBI that I was planning to come to their corporate headquarters and go on a killing spree but in reality was I was close to meeting with CNN, Atlanta and doing a 'show & tell'. This would have destroyed or made the stock value of numerous Fortune 500 Corporation plummet. I had been receiving nastygrams and threats so I got a single barreled 12 gauged shot gun from my brother for my protection. I had already tried to tell the FBI but they would not believe an already federally convicted felon over a Fortune 500 corporation. They came to my rural Chester County home and arrested me for felon in possession of a firearm.

When I arrived in federal court in Columbia, SC I attempted to tell the court that I was an electrical engineer who designed nuclear power plants and there is a nuclear power plant cyber security cover-up. They thought I was insane because I had already served a federal sentence and I had no formal technical training and no degree. Shaw had legal representation in the court room but they refused to tell that I actually worked for Shaw Nuclear. Federal Judge Cameron Currie ordered me to be sent to Englewood (Colorado) Federal Detention Center for a mental evaluation where I was placed under the care of Dr. Jeremiah Dwyer, PhD, federal psychologist employed by US Bureau of Federal Prisons. While there I was offered \$5,000,000 after I had given Dr. Dwyer documents to confirm my previous employment at Shaw Nuclear.

I was given a cellmate named Montgomery Chitty who had a past in politics. He was a close friend to US Senator Gary Hart. The same Senator Hart that was in a scandal when he was a candidate in the Democratic presidential primaries. Chitty was responsible for introducing Senator Hart to William Dixon who ended up as Hart's campaign manager. Chitty and Dixon remand friends and stayed in contact. Chitty sent a copy of the "Nuclear Cyber Security Cover-Up" to Dixon.

Dixon was an attorney that worked for a law firm in Wisconsin which just happened to be the same law firm that Barack Obama worked when he graduated from Harvard Law. Dixon and Obama became smoking buddies because they stood outside and smoked together. This made Dixon have the ultimate inside contact at the White House.

It was late summer/early fall 2012 and Dixon sent the story to the White House. Obama was already president and it was about 2 months from the 2012 Presidential Election. Chitty and I had spoken with Dixon on a number occasions and Dixon informed us that the White House did not want this to go public before the November Presidential Election and Dixon informed us that I would be moved and held in an undisclosed location until after the election. I was immediately shackled and shipped from Englewood Federal Detention to Colorado Springs to Oklahoma City to Atlanta to Ocilla, GA and placed in a privately owned and operated prison facility where I was told, "no sending or receiving mail and no phone privileges". The facility is called Irwin County Detention Center but it is privately owned.

Obama was re-elected and I was shackled and ship back to Lexington County Detention Center where I was held until my competency hearing. At the competency hearing Dr. Jeremiah Dwyer appeared on the video conferencing monitor and began to tell the court that I was delusional and I had never worked for Shaw Nuclear designing nuclear power plants. It was obvious that the federal psychologist had accepted a bribe to lie in federal court.

Federal Judge Currie then ordered me to be sent to Butner Federal Medical Center located inside Butner Federal Prison and be treated for being severely delusional because I said "I designed nuclear power plants and there's a cyber security cover-up".

Immediately I arranged for an individual on the outside to assist in smuggling sensitive nuclear documents into the federal prison's mental ward. Meanwhile the Shaw Group/Shaw Nuclear had come to the realization that everything I had told them was true. "It was going to be IMPOSSIBLE to cyber secure the nuclear power plants". Shaw immediately sold the Fortune 500 Corporation to Chicago Bridge & Iron (CB&I) without informing them of the cyber security issues. Simultaneously Duke Energy, who was/is a major client of Shaw Nuclear began to divest itself of all nuclear interest outside of the Carolinas. I had worked on Duke Energy's projects as well.

The offers for me to keep quiet escalated from \$5,000,000 to \$8,000,000 to \$10,000,000 and I would not accept because deals of that nature should not be negotiated while you're incarcerated and this cover-up needed to be told and I had a manuscript that would tell all. Besides, if this were to go public I would be in a position to sue multiple Fortune 500 Corporations and they would be forced to settle with record breaking settlements because this is nuclear and there was a cover-up. The American people needed to know.

I presented the nuclear documents to the attending psychologist, Dr. Piant who was also a full bird colonel in the US Medical Corp. He realized there had been a serious problem and he asked me "how in the hell did you get a job as an engineer designing nuclear plant"? I then told him the complete story. He then informed me that the court had ordered me to stay there at Butner Federal Prison Mental Ward for 6 months. At that point I was not given any more treatment sessions and for the remainder of my time there I was allowed to mingle with the regular inmates where I became the piano instructor and I taught advanced mathematics.

After 20 months of being moved from place to place over 25 times and not yet been sentenced I was sent back to Lexington County Detention Center for sentencing where I was assigned a CJA (criminal justice act) attorney, Jeff Bloom. Bloom subpoenaed copies of my employment documents and he realized I actually did design nuclear power plants so he arranged for Dr. Vincent van Brunt (PhD Chemical Engineering) to visit me at the detention center. Dr. van Brunt is a member of SC Governor Haley's Nuclear Advisory Council and is the state's nuclear guru in addition, he is the head of the Chemical Engineering Department at the University of South Carolina.

During his visit he and I discussed everything technical from how to extract the radioactive isotopes tritium and deuterium from the hydrogen atom to how the Iranian's uranium enrichment centrifuges were hacked and sabotaged when the Iranians were attempting to enrich uranium to weapons grade. The Iranians systems were being controlled by the exact same networks and control systems which were being designed into the United States new generation nuclear facilities and the reactors that were being rebuilt. When the visit was over Dr. Van Brunt knew that it was going to be impossible to cyber secure the nuclear power plants. In addition, he knew because I was able to infiltrate nuclear, there could be terrorist already in nuclear working as engineers.

Steve Byrne, who is a corporate officer with South Carolina Electric & Gas and also a member of the Governor's Nuclear Advisory Council also knew of the inability to cyber secure the nuclear facilities but

because of him being a stockholder with SCE&G he wouldn't go public because he would have personally experienced a loss of more than a million dollars.

Jeff Bloom advised me that I had already served 21 months and if I were to sign a guilty plea I would be sentenced to 30 months of which I would have to serve 85% which would be 26 months. I sign a guilty plea and was sent back to Ocilla, GA then to Atlanta Federal Prison to Lovejoy, GA (private prison) to Oklahoma City to Grady County Jail which is in Oklahoma back to Oklahoma City to somewhere in Indiana to Pittsburgh then placed on a bus and delivered to Elkton Federal Prison. This journey took about 6 weeks and when I arrived there I was offered \$12,000,000 which I refused.

I was released and taken to the Greyhound bus station where I boarded a bus and later was picked up in the middle of the night by my wife in Charlotte and she drove me home after 26 months of incarceration and being moved nearly 30 times. Two days later I was approached by attorneys who stated they represented members of the nuclear industry who had authorized them to offer me \$20,000,000. I refused because they refused to invite a member of US District Attorney's office to the settlement table.

QUESTIONS UNANSWERED

1. Why did the psychologist which was an employee of the United States Bureau of Prisons tell the courts that Jasper (Jack) Reeves had never been an employee of Shaw Nuclear as an engineer? Court transcripts will verify.
2. Where did the multiple proof of employment documents come from that proves Jasper Reeves had been employed with Shaw Nuclear for at least two years?
3. Did the White House know of the Nuclear Cyber Security Cover-up considering William Dixon a co-worker of President Obama sent the story to the White House during the summer of 2012? Prison phone records will reveal Dixon communicated with Montgomery Chitty, Reeves' cellmate.
4. Did the Shaw Group arrange for Melba Carter, the female who was responsible for taking the nuclear cyber security blackmail picture, to not be prosecuted even though she admitted that she took the picture in Reeves' home without his knowledge which was an obvious criminal act?
5. How did, Jasper Reeves, a felon with an extensive criminal history which includes very serious computer related crimes and serving a federal sentence and having absolutely no technical training of any type become a senior staff electrical engineer with Shaw Nuclear?
6. How could a psychologist, who possessed a Doctorate of Philosophy in forensics psychology, mistake an individual with an IQ in the 150s as being delusional and never designed nuclear power plants when the psychologist had in his possession proof of employment which confirmed Reeves had worked for Shaw Nuclear?
7. Why did Federal Judge Cameron Currie allow the psychologist to give the false diagnosis when the judge and the psychologist had in their possessions authenticated documentation which would solidly confirm Jasper Reeves did once work at Shaw Nuclear?
8. Since Jasper Reeves did work for Shaw Nuclear as an engineer why it is not possible for a terrorist element to presently be employed within the nuclear power plant design industry?
9. Jasper Reeves is a hacker that was able to infiltrate nuclear and has been attempting to convey that it was going to be impossible to cyber secure the nuclear power plants. Can the nuclear power plants be cyber secured? And how? Prove it.

10. After Reeves reveal the cyber security and human resources issues to management at Shaw Nuclear, corporate officers of the Shaw Group immediately decided to put the Fortune 500 Corporation on the market and it was purchased by Chicago Bridge and Iron. Was this a coincidence or fraud?

11. Why was Reeves moved from place to place within the Federal Prison System at least 25 times within a 20-month period prior to being sentenced?

End of Story.

Airing the full spectrum of this story could prove to be detrimental to Governor Nikki Haley, Dr. Vincent van Brunt and Stephen Byrne. Dr. van Brunt has dual obligations with the state of South Carolina. 1) Professor of Chemical Engineering with the South Carolina State University System. 2) South Carolina Nuclear Advisory Council as the states most knowledgeable nuclear expert. Dr. van Brunt chose to conceal the that the nuclear facilities could never be cyber secured which is clearly a criminal act.

Stephen Byrne who also is a member of Governor Haley's Nuclear Advisory Council is also a corporate officer of South Carolina Electric & Gas/SCANA Corporation who holds the position as President of Generation. Holding these two positions are clearly a conflict of interest simply because Stephen Byrne position as a member of the South Carolina Nuclear Advisory he has a fiduciary obligation to the people of the state of South Carolina to insure their safety. In addition, Stephen Byrne, as President of SCE&G/SCANA, has a substantial vested interest as a stockholder and by not going public with the fact that it is not going to be possible to cyber secure the nuclear facilities clearly shows Byrne concealed this information to protect the value of SCE&G/SCANA's stock. This is clearly a criminal act.

The United States Department of Justice including the United States Bureau of Prisons, the United States Federal Bureau of Investigations and well as other federal agencies and a number of their employees played a crucial role, knowingly and unknowingly, in the Nuclear Power Plant Cyber Security Cover-up. Dr. Jeremiah Dwyer, the federal psychologist responsible for performing the mental evaluation knowingly lied in federal court by telling Federal Judge Cameron Currie that I had never been employed designing nuclear power facilities. The psychologist had in his possession documents which clearly showed I did work for Shaw Nuclear in a technical capacity. Federal court transcript will confirm.

For obvious reasons if the Nuclear Power Plant Cyber Security Cover were to go public the United States Department of Justice and all related agencies would face an embarrassment which would expose corruption within the United States Justice system. In addition, the United States Department of Justice would be forced by the American people to indict and prosecute any and all individuals involved in perpetrating this series of criminal acts. They would have no choice but to indict all state officials and corporate officers who played a role. This has the potential to be served up to the American public as the "Scandal of the Century" and Nikki Haley, the governor of South Carolina knowingly played a role.

Under Civil Conspiracy Laws the State of South Carolina, including Nikki Haley herself could easily qualify as defendants along with the following corporations:

The Shaw Group	


The documents enclosed which will support this also includes a document which will reveal United States Senator Tim Scott was well aware of this cover-up and chose not to go public because Senator Scott received enormous campaign contributions from SCE&G/SCANA. This scandal will also encompass the Oval Office of the White House. To exacerbate the situation, I'm a Black man with an IQ which exceeds

150 which is well into the genius range and I worked as an electrical engineer designing nuclear facilities with no formal training, no degree after I was released from federal prison. "Black Lives Matter" will take on a whole new persona which will fuel the possibility of Governor Haley's impeachment.

There is a possibility that my negative public response to this situation could be mitigated or total eliminated if the corporations involved are will to meet and settle this matter. The United States Department of Justice DOES NOT want this matter to go public because their competency will be questioned not to mention this story will imply, without a doubt, there is corruption within the United States Justice system. Every mental evaluation ever performed by federal psychologist Jeremiah Dwyer would stand a chance of being reversed and that would clog the federal docket of every district which Dwyer performed mental evaluations for that district's defendants. This would trigger the possibility of every mental evaluation to be scrutinized and this would only be the tip of the iceberg of the negative possibilities.

It is imperative that a representative from the USDOJ be present if Governor Haley, along with the aforementioned corporations, decides to try and mitigate this possible scandal. Promptness is imperative if Governor Haley intentions is to curtail this situation which will impose irreversible damage to her political career. I will assume if I have not heard from the governor's office within 10 business days that she has no interest in resolving this matter prior to it going public.
