Governor Nikki Haley News:

Post and Courier: Gov. Haley invited to lead South Carolina's convention delegation; Lindsey Graham to skip it

If Gov. Nikki Haley wants to go the Republican National Convention next month, the state GOP is holding her a spot. But party leaders have already planned on U.S. Sen. Lindsey Graham being a no-show. The state party released its list of officers who will lead the South Carolina delegation to Cleveland. Haley is named as an honorary chairman, alongside U.S. Sen. Tim Scott. While Haley said she would back Donald Trump as the presumptive GOP nominee, she also was highly critical of his conduct during the primary campaign. She alluded to him in her State of the Union response by asking voters to resist following "the siren call of the angriest voices."

The State: Road-repair plan with Malfunction Junction fix heads to governor's desk

S.C. House members sent a \$4 billion road spending plan to the governor's desk on Wednesday. That plan includes a fix to Malfunction Junction, replace nearly 400 bridges and give the governor more control of the Transportation Department. The proposal approves bonding about \$200 million a year for Transportation Department projects through the S.C. Transportation Infrastructure bank.

Note: Many GOP lawmakers and Gov. Nikki Haley pushed for the governor to have more control of the Transportation Department.

South Carolina House members overwhelmingly approved a major roads bill that, if the governor approves it, will send billions to fix state highways and bridges and change the state Department of Transportation's governing body. The move came after years of proposals, negotiations and failed starts that culminated late Tuesday night when, amid an impasse, the Senate revamped how SCDOT Commission members were appointed. Senators kept a funding provision that lets transportation officials leverage \$200 million a year into \$2.2 billion worth of bonds over the next decade to fix interstate and bridge priorities across the state.

Gov. Nikki Haley is backing another opponent of a longtime S.C. senator. Haley is expected to endorse Republican Wes Climer, a Rock Hill financial adviser running to unseat state Sen. Wes Hayes of Rock Hill, Climer said Wednesday. Haley will campaign with Climer, a former York County GOP chairman, at a barbecue at his home next Thursday at 6 p.m. The endorsement pits Haley against Hayes, who has been in the state Senate since 1991 and served in the S.C. House since 1985 beforehand.

Note: “Wes Climer is a conservative businessman who is leading the fight for term limits, lower taxes and good government reform,” Haley said in the release. “If we are going to change the way the Senate works, we are going to have to change senators.”

Leatherman Sr., on several policy differences and called him the “hardest part” of her job. “Sen. Leatherman has always been very respectful to me in person. He’s a nice man but my job is not to go and help respectful and nice people,” Haley told the crowd of about 200. “My job is to make sure that we have fighters who help the people, not their own pockets. I will tell you, the hardest part of my job these last five years has been Sen. Hugh Leatherman.”

They have adopted two of them: Zack, 17, and Devin, 8. “Fostering is all about being there for children in their time of need,” said Hope Smith, who works with Kid In Development Services LLC, an early intervention program. “We provide them with a safe house until they can be placed back with their family, or in another long-term placement.”

Note: Earlier this year, the Department of Social Services launched a foster care recruitment campaign. In March, Gov. Nikki Haley endorsed the recruitment campaign called “Champions for Children” with a goal of recruiting approximately 1,500 new foster parents in South Carolina.

The Legislature has given final approval to a \$7.5 billion spending plan that increases spending on K-12 schools by more than \$300 million and provides technical colleges more than \$100 million for building improvements and equipment. The House's vote Wednesday sends legislators' compromise to Gov. Nikki Haley, who has a week to issue her vetoes. Legislators will return June 15 to deal with those vetoes before the fiscal year starts July 1.

Legislators are working toward a compromise on legislation designed to jumpstart improvements to South Carolina's deteriorating roadways. With just one day left in the legislative session, the dispute between the House and Senate is over how the Department of Transportation's commissioners would be chosen. Both chambers' proposals allow for \$2 billion in borrowing over 10 years for infrastructure, funded with \$200 million annually in existing fees and vehicle sales taxes. The chambers agreed to the borrowing plan after senators blocked proposals increasing gas taxes.

The Legislature has approved freeing South Carolina State University from \$12 million in state loans and set up a 16-year repayment schedule on a separate, \$6 million loan. The resolution approved Wednesday by the House formalizes the terms agreed to last week by a legislative panel negotiating the state budget. The Senate approved the resolution Tuesday. It forgives \$8 million next fiscal year, then \$2 million each in the following two years.

Members of the subcommittee who heard from Tosha Autry on May 5 warned her to be careful before she spoke and even had the perjury law read to her twice, but her comments left them little choice but to recommend the criminal investigation, subcommittee chairman Kirkman Finlay said Wednesday. "None of us had hoped to end up here," said Finlay, R-Columbia. "These rules give us a clear path forward. One that I hope we don't have to use at all again."

The State: Rising seas put brakes on developers' march toward the ocean

Following years of debate, South Carolina took steps Wednesday to stop developers from building high-rise hotels, condominium buildings and other major projects close to the ocean after taxpayers spend money to renourish public beaches. The S.C. House passed a bill that will close a loophole in state law that has allowed new construction closer to the ocean when renourishment projects temporarily widen the seashore. While the legislation gives a short-term reprieve to developers at Kiawah Island and other places, the lower chamber's action is considered a significant, long-term step to prevent construction farther out on the beach at a time of rising sea levels.

The narrow neck of Capt. Sam's Spit might determine whether a controversial 50-home development is built on the popular outcropping. The state House of Representatives on Wednesday unanimously approved a compromise bill that prevents a regulatory setback line from being moved to allow building any closer to the beach after 2017. The position of the line could determine whether there's enough legal space to build a controversial road across the narrow neck access to the spit to a development proposed by Kiawah Partners. The neck is eroding on the riverbank faster than its beach is accreting, survey work by the College of Charleston has indicated.

Note: The vote was 114-0. The bill now goes to Gov. Nikki Haley for approval or veto.

Eleven years after mental health advocates sued South Carolina over the treatment of mentally ill inmates, prison officials said Wednesday they have reached a final agreement on how to reform inmates' care. The Department of Corrections announced the agreement with Protection and Advocacy for People with Disabilities on a plan to establish timelines and goals for settling a 2005 lawsuit. It still needs court approval. The state and the advocates have been in mediation since 2014, when a judge sided with the advocacy group.

After years of contentious litigation and negotiations, a tentative agreement has been reached that could sharply upgrade the treatment of an estimated 3,500 mentally ill inmates at the S.C. Department of Corrections. The agreement in the long-running class action lawsuit is between the South Carolina-based Protection and Advocacy for People with Disabilities, Inc. and the Department of Corrections, according to a joint press release Wednesday by both parties. A major feature of the proposed settlement, which still must be approved by a judge, would create an independent process to monitor implementation of the plan that parties to the lawsuit say would transform the culture and performance of SCDC personnel who deal with offenders with serious mental illnesses.

Clinton, Trump's likely general election opponent, cast Trump University as a get-rich scheme for the real estate mogul that preyed on vulnerable Americans, urging them to sign up for pricey seminars even when they were financially strapped. "He is trying to scam America the way he scammed all those people at Trump U," Clinton said during a campaign stop in Newark, New Jersey. "It's important that we recognize what he has done because that's usually a pretty good indicator of what he will do."
