Sounds good – I did a v35 and just made a few changes, noted below. Except to respond to your comments, I did NOT read agency pages on this pass-through. I expect that every second of my morning will be burned...I'll have to make final tweaks to the slide deck, then brief legislative staff, then talk to Seanna, then talk to NRH, then the presser. That should be done around 1, and then I'll probably have to answer a few press questions. So if you print it when you think you're done with your stuff, which should be mid-morning, then I'll do a quick, final flip-through post-presser, and then we can publish it. The goal would be to put it up within an hour after the presser ends. I don't expect to really have changes, but want to do one final pass.

- In cover letter, I made it "25" new parole agents.
- Let's have DOT send us a few bulletpoints on what using the Act 114 criteria would mean – folks are gonna ask us about that, and we should have a common answer.
- The "maintains Base Student Cost" passage in the cover letter – we should discuss.
- Added "including for Film Incentives" to note at bottom of Annual Change in Approps chart.
- S&U chart: Is it April 2014 or June 2014 for that 2<sup>nd</sup> MSA payment? Gotta check Loftis memo. If we have to change it, we also have to replace Funds Placed in Reserve chart.
- Reserve chart: I don't know what the \$67M is...that was a line you put in there originally that I tried to reword in guessing what it was...probably has to come out? Also, is the last line right? Is that a GF balance or a CRF balance? And is it still a real number?
- Made a series of minor wording changes all over.
- Replaced the tax chart. It's v4B.
- Replaced the healthcare chart. It's v5.
- I think the public safety chart has already been updated...no?
- On HHS, just fill-in the blanks for those XXX numbers, and we're done. Either you get Medicaid or you don't...we talk about it enough elsewhere, I kinda don't feel like we need to belabor the point on that page. The sale either will or won't be made independently of what's on that page in a bullet-point.
- DMH increase should be correct – I changed that yesterday when I redid the chart.
- PRT: Sounds like you're good, so I deleted the highlighting.
- Commerce: Closing Fund...yup.
- Revenue: Let's talk to Rob about what to call the loan repayment – they don't seem to be shying away from talking about the data breach, so they might keep the name...she had me add a slide about it.
- 117.51: We'll have to figure that out Thursday. Maybe call Brenda and see what she thinks? I think both Les and Debra are out.
- 118.7: Yeah, delete – confirmed with Les
- 118.8: I struck the highlighting, genericized the note, and removed the highlighting. I think we're gonna have to amend it. We'll work it out with Debra.
- I threw the seal in at the end.

Also, questions we'll be asked at the presser and should be ready to answer:

- How much new money does HHS get in total, across all funds?
- How many new personnel for SLED?
