RE: The use of habitual offenders as Confidential Informants

To whom it may concern,

Please take a moment to consider the information that I'm going to share with you as the majority of the people that I have spoken with are in agreement and know or have known someone that has been in this situation and would like to see changes made. We also have a petition to follow. We consider what is happening with the use of habitual offenders being used as confidential informants a type of DISCRIMINATION and refuse to go unheard. If this information isn't considered, we'll take it as far as we need in order to be heard, but we hope and pray that at least one of you will put yourselves in our place and hear our cry for justice.

My name is Tammy Hill. I was a dispatcher for the York County Sheriff's Office in York County, SC, from 2010-Dec. of 2014, until I was basically "harassed and discriminated against" until I felt I had no choice but to resign. I'm on the side of law enforcement and know the types of calls for service that they respond to and put their lives on the line for every day. However, I had no idea of the tactics used by the DEU in order to convict others on drug charges until my own son was involved. Once I reviewed his case file, I was appalled at our judicial system's concept of using habitual offenders as confidential informants. I'm including a portion of his file so that you'll understand that this isn't just my opinion. It's all based on facts in the case. It's in front of you in black and white. These particular informants are used repeatedly and when reviewing their criminal history and every charge that has been dismissed or "coincidentally" had very little or no

convictions, it has basically left me speechless! I'm not sure how many "first time offenders" have been set up by these individuals, but I'm sure that my son isn't the only one.

In or around the end of November 2013, my son, Joshua Brookins became a "friend" of Travis Pope and "acquaintance of "Charlie Bowker". Before their friendship, Josh's criminal record consisted of driving under suspension (due to a lapse in insurance coverage) and a simple possession charge from 2007/2008, when he was a teenager. He was prepared to fight that charge by asking for a jury trial because it was found in the floor board of a truck that he had just bought. His letter notifying him of his court date was sent to a previous address; therefore, he missed his court date and was found guilty. He currently has a 6 year old daughter, Mckenzie, and his 2<sup>nd</sup> daughter is due April 4<sup>th</sup>, 2015. After hanging around the two subjects, Josh became a user of Meth. I wasn't aware of this until after his arrest in March of 2014. The York County DEU advised me, by phone, that they had been watching Josh since November of 2013. I didn't and still don't understand that considering Josh was in the York County Prison for the previous 60 days for getting behind on his child support and had just been released Nov. 10, 2015. Why were they watching him? He had no criminal history. They were watching him because Travis and Charlie were working for the DEU as confidential informants. Charlie had recently been arrested on drug charges on Nov. 23, 2013. During the period of December 2013-March 2014, the DEU set up several busts involving Josh. There were four total, the first one being Dec. 6, 2013. The last being the "buy/bust" in March of 2014. They basically set him up, without arresting him, until the last one. During the arrest on March 27, 2014, they added an additional 3 charges from the previous 3 set-ups. The charges consisted of 3 counts of distributing and the last was trafficking. He spent approximately 2 months in jail before I had the money for bond. His bond was set at \$45000.00. Once he was released, he never looked back. He cleaned himself up (on his own, without outside help) by eliminating his "friends" and not putting himself around people like that or drugs. What I haven't told you yet is that the two subjects, who were also arrested, are walking the streets because they are confidential informants. Both have an EXTENSIVE criminal history that includes multiple recurrent drug charges, armed robbery, violation of probation and much more. Copies of their criminal histories are included with this statement; however, they are only through November of 2013. More charges are pending at this time. One point I would like to make is that if they would've arrested Josh

after the first "set-up", I can assure you there wouldn't have been a second. Just like after his arrest. Unlike most Meth addicts, he turned his life around. Since when did it become okay or even legal to use habitual offenders as confidential informants? They should be behind bars instead of being allowed to set-up first time offenders. The opportunity to become a confidential informant should be given to the first time offenders in order to possibly clean themselves up and lessen their sentence. As it is right now, both of them are still walking the streets. Still distributing, using, and even soliciting drugs to non-users who possibly wouldn't have even tried the drug if it weren't for them soliciting it. A victim, just as my son was. My son was sentenced to 15 years, 5 suspended (of which he has to do 85% of), 5 years probation, 500 hours of community service and drug rehab. All for 1<sup>st</sup> offense! He was given the opportunity to assist the DEU by setting up a subject from the Greenville/Anderson, SC area but Josh refused due to endangering his children and his family. I'm not sure if that's why the DEU pushed for such a harsh sentence. The Solicitor wanted to try Josh on each individual charge consecutively in order to have him convicted of 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> offense in order to maximize his sentence. The Judge agreed to let Josh plead guilty, first offense, to all charges. In return, Josh was led to believe by his public defender that he would be sentenced to 3 years (the minimum for first offense), along with probation, etc. If you'll take the time to look over the confidential informants criminal histories, you'll understand why I'm/we're so upset and angry. They, again, continue to use, sell, distribute and solicit to others who otherwise may not ever use drugs. They know if they're caught, all they have to do is set-up, "roll-over", on someone else, as they did my son. How is this fair? I know there are guide lines concerning confidential informants, but HABITUAL OFFENDERS?

I had to resign as a dispatcher a couple of weeks after Josh's conviction. I'd never been in trouble or reprimanded for anything until after his court date. I was called into the office and told I needed counseling because of my "anger" over my son's conviction. However, I hadn't shown any anger of any sort while on the job. I agreed to counseling in order to keep my job. Shortly after that I was offered a position dispatching for another company. I was seriously considering it due to our schedule. The next week I was called in the office a second time. This time only to be told that the Sheriff didn't want me dispatching or having anything to do with law enforcement. I could dispatch fire, ems, or answer the phone lines. He stated he was concerned that I wouldn't treat the DEU the same as I did the

other officers. Even though I had never given him any reason to think this. My job was to make sure they are safe at all times and that they return home at the end of shift to their families. I took my job very seriously, regardless of who was on duty. With that being said, even though I loved my job and my strength was law enforcement, I accepted the other job offer. Due to feeling as if I was being discriminated against and harassed, I didn't have a choice.

The facts of this issue are still valid and to many of us unfair. A perfect example of DISCRIMINATION. I've hired an attorney to try and help get my son home before 10 years, in order for him to enjoy his family and friends just as the HABITUAL offenders do every day.

Thank you for your time and I look forward to your response. Any assistance you can give us is greatly appreciated.


