



To Whom It May Concern:

I am writing today to put in my formal complaint against your agency SC DEW. I received a Notice of Overpayment applied to debt form from SC Department of Revenue advising me that my refund had been taken and applied to my husband's debt. I am in no way responsible for his debt and that is why when I filed jointly I included a Form 8379 Injured Spouse form to protect me from his debts. I have to file each year jointly because we are legally married and we share a son. Each year Child Support SC Department of Social Services normally takes my refund and I have to contact them and I sent a copy of my W2's along with the tax return and injured spouse form and they refund me my portion. When I received this notice I immediately contacted Ruby Jefferson at (803)737-1908. After several messages she called me back and advised me to contact SC Department of Revenue to ask for a refund. I advised her that I normally have to contact the agency who took the refund but I went ahead and followed her instructions. I spoke with person at Department of Revenue and they said that they have nothing to do with it because the funds were given to SC DEW. I then called Ruby Jefferson back and she told me that she had never had anyone ask for a refund and would have to follow up with her supervisor Brian Johnson. Brian Johnson then called me today and said that they didn't have a process of refunding monies back. I advised him that this was not my debt and that I did not owe SC DEW and that you are holding onto my refund. I agree with taking his portion but my portion is not owed to you. So that is the reason that I am writing you today to ask that you contact me about refunding my portion of the refund that is owed to me. Please note that I will be faxing this letter of complaint to the Governor's office as well. I can't believe that your agency does not have some type of process of refunding an injured spouses portion back. Please contact me ASAP so that we can resolve this issue.
