Thank you so much Dominique! So enjoyed meeting you and chatting yesterday. It has long been of dream of this history loving woman to visit the White House!!!

Congressman Norman asked at the end of the Summit yesterday for suggestions on topics /concerns to be addressed at future summits. As I mentioned to you yesterday, I am interested in advocating for and increasing awareness of the needs of our young people in Recovery to be able to safely return to Colleges and Universities. Unfortunately our institutions of Higher Learning are, for the most part, not Recovery-safe environments, and are in fact a hostile environment for students seeking to remain sober. I agree strongly with the Association of Recovery in Higher Education that our young people should not have to choose between sobriety and a college education. Nationwide, the 18-24 year old age group is the fastest growing demographic for Americans seeking treatment for substance use disorder. It is estimated that 22.9% of our 5.4 million American college students meet criteria for substance use disorder. We cannot afford as a nation to lose this many of our 'best and brightest' to the dysfunction and high death rate of this horrible disease. I have started collecting information on what SC Colleges and Universities are doing and I am dismayed at what a low priority this is given at most. Most Collegiate Recovery programs are student led, without any full time, professional staff or dedicated space. I am, true to Republican values, dedicated to mobilizing like-minded individuals to commit to solving this issue, without government intervention, but there are legislative precedents. Governor Chris Christie in 2015 signed legislation requiring campuses in New Jersey to provide Sober Living accommodations in any college/university with more than 25% of their population residing on campus. Sorry for such a long e-mail, but I know we share a personal and professional passion for this subject, so I appreciate any suggestions/ connections /comments you may be able to share to help me as I take some first steps down this road.
