MINUTES

Mr. Poore called the meeting to order and Mr. Wright gave the invocation.

Mrs. Lyn Friedman, Membership Chairman for the Anderson County Association of Retarded Citizens, requested Council to proclaim the week of February 13-19, 1977 as Mental Retardation Week. Mr. David Hooper suggested that Mr. Poore sign the Proclamation and Mr. Poore stated that he would be happy to do so.

Mr. Wright discussed a proposed Budget Calendar in regard to the preparation of the Annual Budget Ordinance. Mr. Hehn discussed the Budget Calendar in detail. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt the Resolution.

Mr. Poore stated that Mr. James Campbell had requested an additional typewriter for the Manpower Office. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to authorize Mr. Hehn to purchase an additional typewriter for the Manpower Office. Mr. Hehn stated that Mr. Robert King from the Civil Defense Office was able to acquire a surplus typewriter; and, Mr. Hehn stated that he is trying to determine the cost to repair this typewriter. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to authorize Mr. Hehn to use his own judgment whether to acquire a new or used typewriter for the Manpower Office.

Mr. Wright discussed a proposed Ordinance which would schedule Council's meetings. As the proposed Ordinance is presently written, Council would have to meet twice in one week during the months of June and December. Mr. Wright stated that with Council approval, prior to third reading and final adoption of the Ordinance, he had included a provision which would provide in the event that the meeting dates of the informal meetings shall fall within the same week as those of the formal meetings, then the meeting dates of the informal meetings shall be held the next subsequent Thursday. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adopt the Ordinance scheduling Council's meetings as amended by Mr. Wright.

Mr. McClellion stated that he had been served with a condemnation proceeding in regard to Lake Hartwell. Mr. McClellion stated that the County, by procedure, is made a party to all such condemnations. Mr. McClellion said he did not feel Council would object to the condemnation; however, he would investigate the manner further if Council so desired. Mr. Hooper suggested that Mr. McClellion investigate the manner and report back to Council.
