Re: Senator Richard Cash's [Amendment No. 22](#) defunding state-funding of rape and incest "abortions" in the SC State Health Insurance Plan; and in life of the mother cases, limiting state-funding of pregnancy termination to procedures incidental to the lifesaving intervention (e.g., removal of ectopic pregnancies as necessary according to the medical standard or care).

Note: Removal of an ectopic pregnancy to prevent potentially fatal hemorrhaging is not an "abortion", but will cause or complete the termination of the pregnancy which is incidental to the lifesaving intervention.

The Amendment states: "The physician shall act in accordance with the standard of care to preserve both the life of the mother and the life of the pre-born child." Likewise, removal of a pregnant woman's cancerous uterus is not an "abortion". Premature delivery of an unborn child is not the same as intentionally destroying the child first inside the womb. The text of this Amendment requires the physician to act "to preserve both the life of the mother and the life of the pre-born child."

/// There were two attempts to table (kill) the Cash pro-life amdt. on April 11. The first by pro-"abortion" Senator Margie Bright Matthews, Esq. failed on a 17 Y - 25 N vote. Among the 15 D's and 2 R's voting to table (the pro-"abortion" vote), were Dem's **McElveen** and **Reese**. The two "Republicans" (RINO's) were **Massey** (Senate Republican Majority "Leader") and **Rankin** ("former" Democrat, and Chairman of Senate Judiciary Comm.).

/// The second tabling motion by leading pro-"abortion" Senator Brad Hutto, Esq. (JESUIT Georgetown Univ. Law Center grad.) was successful on a 23 Y - 19 N vote.
