As you are aware, full implementation for the SC ALIR system is slated for September 15, 2004. With implementation, the fee that insurers contribute to the Uninsured Enforcement fund will increase from \$1 to \$2. Based on input from insurers, the Department of Motor Vehicles has modified its calculation method for determining the fees due to DMV.

Attached please find a revised group of FAQs and a revised Form FR290 which should be used to report the fees remitted.

The first reporting quarter ends on September 30. With your October payment, please remit all fees that you collected for the uninsured enforcement fund for the quarter ending September 30. If you have any exceptional circumstances, please report them on the form.

For the quarter ending December 31, 2004, DMV expects that you will remit the \$2 annual fee for the full reporting quarter.
