### Director Clark:

I want to bring to your attention and immediate action that four (4) white boys who I had never seen before physically stopped me and forced me to talk with them earlier this month (*June 4, 2008*) at my parent’s home here in Fairfax County, Virginia. **Two of them even entered my parent’s house without permission and without a search warrant.** The two who illegally entered my parent’s house without permission and without a search warrant told my elderly mother when she found them in her living room that they work for Fairfax

County. All of these four (4) white boys had initially identified themselves as Deputy U.S. Marshals but only one of them, a so-called **John Mainer**, knew/could recall his name. None of the four alleged white Deputy U.S. Marshals had a business card, knew where their office is located or even knew their phone, fax number or email address. The so-called **John Mainer** did pull out of his shirt on a cord around his neck a sweaty badge when I asked him who he was, but as I politely told him, the badge looked like something anyone could buy at a local Wal-Mart store.

I hope you realize that real Deputy U.S. Marshals and even Fairfax County white thugs need to properly identify themselves and to know and be able to recall their names, work address, phone number, fax number and email address. Based on the number of times I have been told that I would be killed if I did not "**KEEP QUIET**" concerning my knowledge of what by metro Atlanta born and reared wife tearfully told/warned me for several years is just typical "**SOUTHERN BIGOTRY and CORRUPTION**" – these four (4) white boys were fortunate that I did not attempt to defend myself.
