To Whom This Letter May Concern:

I bring forth to you today a series of events that I have endured, having an effect on me personally as well as the welfare and safety of my family. I ask that you listen to my testimony and help me. I sent a certified letter to President Obama, every Governor and Presidential candidate of my ordeal which involves organized crime, extortion, theft of services and filing of a false police report. I suffered from police brutality while in their custody. I have reason to believe I experienced hypothermia in their custody in April of 2014.

Instead of responding to my letter with help answering my unanswered questions, I came home only to be ambushed by Delaware State Troopers with assault rifles pointed at me, as well as being abducted for the 3rd time and taken into custody over these matters. Because of my letter and seeking out the truth, I was taken to the mental health hospital where I was told by staff that their laws trump my constitutional rights and that I need do what they tell me. I was threatened with physical force and violence for not wanting to comply in letting them draw my blood. While in the mental facility for a period of about 3 weeks I was given an injection for refusing to take the medicine by mouth they wanted me to take. Medicine they thought I needed to be on. These events took place September 2015.

I had committed no crime or wrong doing on my part, just trying to get answers as to what happened to me, yet I was hauled away and told that I was delusional and psychosis and forced to take medicine. I believe these acts against me to be unlawful, not to mention the fact that claims for treatment were sent to our health insurance company for payment without any authorization on my behalf for any of the services. The fact remains that absolutely no one ever attempted to check out my story, and was simply labeled delusional. There were no tests or studies conducted to prove this. A series of events has happened to me and my family since I've been reaching out and asking for the truth. I've been preparing and asking for a trial for almost two years over my claims against Delaware. I have a contract, pictures, text messages and voice recordings of my encounter with the Delaware State Police. They have refused to hand over any evidence or documents and denied any wrong-doing. I spoke to Jim Wood of Internal Affairs who offered no assistance and stated he really couldn't help me. What makes this matter so unique and alarming is that my allegations are the same allegations that got Hitler convicted of treason before World War II. These kinds of acts are condemned in a court of law.

I feel as though I have been "raised" by the State of Delaware since I was a child. I have been a victim of Delaware officials//government my whole life but these past acts are unexcusable. I have learned the law from them. Please, I beg you to take a look into my past,

beginning as a child here in Delaware. I want you to see how I have been misjudged & mistreated by Delaware even at an early age. I am capable of governing my own affairs. People want to label me as crazy. I believe what makes me different is I see the world through God's eyes and he judges it through mine. I would like to remind everyone of the quote by Abraham Lincoln "Those who deny freedom to others, deserve it not for themselves; and, under a just God, can not long retain it." I believe when a body of government commits crime against their people it becomes a crime against humanity. I am being attacked for standing up for what is right, speaking the truth and reciting the law. I've been trying to make a citizen's arrest all the while to no avail. This is why I have taken the liberty to have this certified letter sent to the US Supreme Court Justices, The Pentagon, Homeland Security and all Governors as well as Presidential Candidates. I will continue to keep sending these letters so when crimes are committed it won't be me facing judgement. I want everyone to know that I continued to ask for help but have been denied. I want Government to address this matter and hold someone responsible for seeing it through. I have many lawyers' phone numbers on my phone records since 2014 regarding these matters who would not get involved because it involved others in the legal community and police. I have signed return receipts from Governor's I believe to be violating the Bill of Rights. They have the power, responsibility and obligation and under oath to uphold the Bill of Rights and the Constitution. They do not have the right to discard my facts. For example, Marco Rubio and Ted Cruz responded with a letter you will find in the back I believe these people are telling the American people they will uphold the oath but then they run from opportunity. This kind of governing is why we're in the trouble we are in now. I believe God has put a fire in my heart and I have the responsibility to stand up for myself and what is right. I believe that anyone person has the right to challenge any one body of government and the government has to respond. Those that deny me my rights, either arrest me or endorse me. A hand-delivered letter was written to Beau Biden in 2014 providing in depth details of my situation. After this, things seem to get worse. I want to know who came in my house and sabotaged electrical wires in my daughter's room so that when touched together, you would be electrocuted or a fire would start. I want to know who came on my property and slashed the tire on my truck. I want to know who came on my property and killed my dog. I consider all these happenings to be use of deadly force. There is someone out there who did this. Tell me, is it against the law for a health provider to force upon someone a drug that has dangerous side effects, even a possibility of death without that person's primary care physicians consent or knowledge thereof? My primary care Doctor, Kimberly Neal had me under her care. She had no knowledge of what the State of Delaware was doing nor did they have her permission or speak with her about the medicine they were giving me. Dr. Kimberly Neal previously told me I was at risk for diabetes. The medicine being forced upon me by injection called INVEGA can cause diabetes along with a *long* list of other possible side effects including dizziness and possibly death! I am a Carpenter who works in the construction industry. The last thing I need is to get dizzy and fall off a ladder to my death. I hope you understand my reasons for believing I was being "soft killed" while under Delaware's treatment.

To my knowledge, the State of Delaware has no law in which you can defend yourself. I have to allow these people to try to kill me because I have to follow the law. I believe in always telling the truth, even if it kills you. I believe to be very patient and forgiving person but someone must bear the blame for this situation. I am familiar with the "RICO" law. I seek prosecution for the said individuals who engaged in the organized crime against me.
