Good morning,

I checked the numbers following our discussion yesterday.

P. 3           The number 8501 is correct.

P. 3           The number 1694 is NOT correct. That number should be 1614. The number 1614 was reported on both -15-16 and 8-18-16 affidavits.

p. 3           The Class Members who received notice (as required by the notice order) were age 14 and older, not 12 and older.

P. 19          The number 3900 is correct as the number of children in foster care on the last day of the 2014-15 fiscal year according to the DSS Child Welfare Flow Chart SFY 2015 which is on the DSS website.

Throughout the order, when references are made to placement of "6 and under" children in congregate care, that reference should be to children who are "6 and under," not "under 6." Examples of this are on pages 6 and 10. This supports the idea of having the motion not reiterate or summarize the agreement but rather state the arguments for approving the agreement.
