

Dear Representative Inglis:

Thank you for your letter written on behalf of your constituents, Nancy and Kayla D. Burgess, regarding South Carolina Medicaid's coverage of a cochlear implant external processing device. We appreciate the opportunity to be of assistance.

Medicaid's coverage of hearing aid devices is limited to eligible beneficiaries under 21 years of age and/or those enrolled in certain Medicaid waiver programs. Ms. Kayla D. Burgess is Medicaid eligible and under age 21, but Medicaid has not received a request for replacement of the external processor. In speaking with Ms. Nancy Burgess, Kayla's mother, our staff learned that Kayla is working with Dr. Hooie of the University of South Carolina's Speech and Hearing Center. Staff contacted Dr. Hooie, and he is to send us a request (along with medical documentation) regarding the need for replacement of the original cochlear implant processor. With this additional information, we expect to be able to approve this request. Once approved, our staff will communicate directly with Ms. Burgess as well as Mr. Dwayne Hatchett of your Spartanburg office. Mr. Hatchett has been most accommodating in the resolution of this request.
