(Charleston County, SC) On February 24, 2016, shortly before 4:00 a.m., Charleston County Sheriff deputies responded to 810 Hoss Road in Ponderosa to investigate a reported shooting. Upon our

deputies arrival, they were advised that the victim was shot in the backyard of the residence during some type of disturbance. The victim was shot in the abdomen with a small caliber handgun. The victim was transported to Medical University of South Carolina to be treated for his injuries.
