*Now, to show that Obama will stop at no expense (human or financial) to keep his deception intact,I am repeating herein, the disgraceful treatment which he allowed to befall former Army Lt.Colonel Terrence Lakin, who gave 18 years of faithful service to our Country,a man who was a recipient of the Bronze Star, and, who had already served a tour of duty in Afghanistan and became a leading flight surgeon charged with caring for the Chief of Staff pilots and air crews.
