The Commission declined to approve a transfer requested by the South Carolina Industrial Commission, substantially changing the set up in that office, on the grounds that the request was signed by only three members of the Industrial Commission. The Budget Commission took the position that such a transfer should have the unanimous approval of the Industrial Commission.

The following allotments were granted from the 1941-42 Civil Contingent Fund:

Industrial School for Girls \$2,000.00, to complete the construction of a fence.

Committee on Investigating Pulpwood Industry \$1,000.00, expense of Committee.

The Commission declined to grant a request for \$689.50 by the Code Commissioner for clerical help during the fiscal year 1941-42, on the grounds that the obligations were unauthorized.

The Commission approved request by the State Board of Health, that certain employees in the Department be allowed to receive additional com-

pensation from the Federal Government, as follows:
