- ~~\*\*\*\*\*~~ Be between the ages of 21 and 35, inclusive, by July 31<sup>st</sup> following the first competition in which she/he participates;
- ~~\*\*\*\*\*~~ Be or have been employed in business or professions, with a minimum of one (1) year of full-time work experience;
- ~~\*\*\*\*\*~~ Understand and support the BPW mission and vision.
- ~~\*\*\*\*\*~~ Ensure that the biographical information, copy of four-minute speech, a

photo are sent to the BPW Board ( [board@bpwgreenvile.com](mailto:board@bpwgreenvile.com)

### **Career Woman of the Year (CWOY)-(geared towards college level careers)**

- ~~Be~~ Be employed, including self-employment, at the time of nomination.
- ~~Be~~ Be living and/or employed in the locale she will represent.
- ~~Minimum~~ Minimum of 31 years of age.
- ~~Local winners~~ Local winners are not eligible for state competition until after a lapse of at least three (3) years.
- ~~Prior State winners~~ Prior State winners are not eligible for consideration again at any level.

### **Woman of Accomplishment (WOA)-( bootstrapping success)**

- ~~Eligibility requirements~~ Eligibility requirements for Local and State Levels: A nominee need not be a member of BPW. Each participant must:
- ~~Agree~~ Agree in writing not to speak out against the mission of BPWSC.
- ~~Complete~~ Complete the biographical information sheet.
- ~~Local winners~~ Local winners are not eligible for state competition until after a lapse of at least three (3) years.
- ~~Prior state winners~~ Prior state winners are not eligible for consideration again at any level.
