Per our conversation, the NYS Department of Corrections and Community agrees to allow Mr. Sampson to serve the remainder of his New York sentence concurrently with his sentence in South Carolina. We have done this with other states by way of an Executive Agreement between Governors which essentially waives the requirement to return him to us under the IAD.
