### Governor Nikki Haley News:

**Associated Press:** Haley vetoes \$41M from Legislature's \$7.5B budget

Gov. Nikki Haley struck \$41 million worth of spending from the Legislature's \$7.5 billion budget and thanked legislators Thursday for not attempting to borrow money for college construction. "We have some major wins this year. The No. 1 win is, there was no bond bill," she said. Last year, Haley's opposition helped defeat proposals to borrow primarily for projects at universities and technical colleges. She publicly warned legislators in January not to try again. On Thursday, she applauded the more than \$100 million the state budget sends to technical colleges for one-time spending on buildings and equipment and \$30 million added to four-year colleges for recurring expenses.

Gov. Nikki Haley eliminated \$41.1 million in funding in the \$7.5 billion state budget, including \$3.6 million for several Charleston area attractions. She also cut out a budget directive calling for a study of the potential relocation of the Confederate Relic Room and Military Museum to Charleston from Columbia. The budget proviso required the Department of Administration to use its funds to identify available building space in the Charleston area by next January for potential new museum locations. Haley said a feasibility study of the relic room's current home, housed inside a separate area within the South Carolina State Museum, has previously been completed and further study is not needed.

**The State:** Gov. Haley vetoes study to move military museum, Confederate flag

Republican Gov. Nikki Haley vetoed a study of moving the Confederate Relic Room and Military Museum from Columbia to Charleston. The museum is the new home of the last Confederate flag to fly on the State House grounds. The proposal to explore moving the Relic Room from the former Columbia textile mill that houses it and the S.C. State Museum **emerged after** even lowered estimates of the cost of displaying the flag at the military museum came in at \$3.6 million. Lawmakers delayed deciding how much to spend to display the flag until at least next year, proposing instead a study on relocating the museum. The flag was furled from the State House grounds **last year** in the aftermath of the racially motivated slaying of nine parishioners at Charleston's Emanuel AME Church.

**Note:** Haley also vetoed a coyote-bounty program that would have required the state Department of Natural resources to tag 16 coyotes across the state.

Gov. Nikki Haley says South Carolina's latest spending plan will help the state's students, health services, and law enforcement agencies. Haley says the budget begins to address the new realities

of the state's pension system while bolstering mental health programs and efforts to combat substance abuse and domestic violence. But Haley has problems with other parts of the budget and issued 51 vetoes targeting a total of \$41,145,000 in spending. In a letter to House Speaker Jay Lucas, Haley says some items in the budget "represent the worst kind of legislative deal-making—pork, pet projects, earmarks, and micromanagement of state agencies."

Governor Nikki Haley vetoed 41.1-million dollars in spending from the state's budget on Thursday. In total, she issued 51 vetoes- 36 less than in 2015 and roughly 11-million dollars more in spending. The Governor says the portions she struck out contain numerous earmarks, pork and pet projects. In prior years, Haley has issued as many as 109 vetoes, amounting to as much 94-million dollars. The Governor referred to several portions of the budget as "the worst kind of legislative deal-making", saying projects have been hidden in budget lines and named vaguely with little explanation of how the funding would be spent. Three vetoes amounted to 465-million dollars from the general fund, and 33 vetoes amounted to 40.1 million dollars in non-recurring funding. Fifteen vetoes had no direct price tag.

Governor Nikki Haley vetoed 51 budget items Thursday totaling more than \$41 million . It's one of Haley's smaller budget vetoes since she took office in 2011. One of the main vetoes was what she calls "hidden earmarks," or items that are listed in the budget, but have no specifications on use. For example, fire suppression, airline recruitment and retention, and air quality items that had no known locations or wasn't ask for by the respective agencies was nixed. She also vetoed funding for a number of museum throughout the state including Gibbs Museum of Art, the SC Military Museum and the State Museum. But she did ok funding for the African-American History Museum in Charleston. In doing so, she said she felt that one was necessary in light of last year's massacre at the Mother Emanuel AME Church.

At least three political groups – including one backing Gov. Nikki Haley's political agenda – are waging a six-figure campaign to topple state Senate Republican leaders in Tuesday's primary. Spending the most — \$500,000 — is a political group, run by Haley's political adviser, that hopes to oust powerful state senators who have clashed with the governor on roads, ethics reform and other issues or fallen out of her favor. Other groups are supporting the Senate incumbents, including the S. C. Senate Republican Caucus, which will spend \$100,000 to back two GOP state senators facing primary opponents.

Haley signed the bill at about 3 p.m. Hips was a Clemson University student who was found dead in Lake Hartwell in 2014 after an early morning run with his fraternity pledge class. Under the new law, South Carolina colleges will be required to post conduct violations concerning alcohol, drugs, sexual assaults and hazing.

After more than two years of discussion, debate and public consensus meetings, the South Carolina General Assembly has passed legislation that will institute a deer tag program as part of SCDNR's hunting and fishing license structure. In addition, the bill will establish a limit on the number of antlered deer than can be harvested across the state. In the waning days of the 121st session, the General Assembly made final amendments and passed Senate Bill 454 on May 26. The legislation has been sent to the governor's office.

Eight Republicans joined 49 Democrats in signing a letter to President Obama opposing leasing the offshore Atlantic for seismic airgun testing for oil and natural gas. The lead signees were Rep. Mark Sanford, R-S.C. and Rep. Gerry Connolly, D-Va. Rep. James Clyburn, D-S.C. was the only other South Carolina delegation member to sign. The federal Bureau of Ocean Energy Management is proceeding with the environmental review process to issue leases for the exploration, after a March decision not to allow drilling in the same area for at least five years. At least three companies continued to want to test off South Carolina after that decision.

Current 10th Circuit Solicitor Chrissy Adams, who is not seeking re-election, said the account is used to pay for health benefits for solicitor’s office retirees. “Wilson Burr has no idea about the inner workings of the solicitor’s office, and that is one of his problems,” Adams said.

Twenty-one states on Thursday sought to take more than \$150 million in uncashed money orders from Delaware, where more than 1 million businesses take advantage of friendly incorporating laws and unclaimed financial property is a major source of state revenue. Texas Attorney General Ken Paxton announced the states would file a lawsuit before the U.S. Supreme Court over an escalating dispute involving uncashed money orders from Dallas-based MoneyGram, which has been submitting unclaimed money to Delaware.

Charleston police say nine people have been arrested and about \$350,000 worth of drugs and cash seized in a sweep tied to the shooting death earlier this year of a Charleston man. ## **The State:** Columbia water customers spared rate increase, but might be hit doubly hard next year

More than 140,000 customers of Columbia's water and sewer system won't face a rate increase this year, but that could result in rates jumping double digits next year, critics warn. City Council on Tuesday voted down a proposed 4.2 percent overall increase over the objections of Mayor Steve Benjamin and Councilwoman Tameika Isaac Devine. Both said that delayed investment likely would trigger rate hikes of 10 percent or more next year – an election year for a majority of council. The vote means city staff must find \$5.3 million – the amount the rate increase would have generated – to cut from the 2016-2017 water system budget. None of the reductions will be to the sewer system, which is under a federal court mandate to make repairs.

President Barack Obama is announcing his formal endorsement of Hillary Clinton. In an online video, Obama calls on Democrats to unify behind his former secretary of state's bid and "build on the progress" of his eight years in the White House. "I want you to be the first to know that I'm with her," he says. Obama is also praising Democratic primary candidate Bernie Sanders for engaging young voters and highlighting the issues of income inequality and money in politics. "Embracing that message is going to help us win in November," says Obama. Clinton and Obama will campaign together in Green Bay, Wisconsin, on June 15.

President Barack Obama formally endorsed Hillary Clinton's bid for the White House on Thursday, praising his former secretary of state's experience and grit, and urging Democrats to unite behind her in the fight against Republicans in the fall. "Look, I know how hard this job can be. That's why I know Hillary will be so good at it," Obama said in a web video circulated by the Clinton campaign. "I have seen her judgment. I have seen her toughness." Obama called for unity among Democrats and vowed to be an active force on the campaign trail. As it circulated the Obama video, the Clinton campaign announced their first joint appearance on the campaign trail will be Wednesday in Green Bay, Wisconsin. The campaign said Obama and Clinton will discuss building on the progress made during his presidency "and their vision for an America that is stronger together."

Thousands of fans, dignitaries and faithful from across the globe filled a Kentucky arena Thursday to honor Muhammad Ali at a traditional Muslim prayer service where he was remembered as a global icon who used his celebrity to promote unity among faiths, races and nations. The service, known as Jenazah, began two days of remembrances for the boxing legend, who died Friday at age 74. Ali designed his final memorials himself years before he died, and intended them to be in his hometown of Louisville, Kentucky, and open to all. "He was a gift to his people, his religion, his country, and ultimately, to the world. Ali was an unapologetic fighter for the cause of black people in America," said Sherman Jackson, a leading Muslim scholar who spoke at the service. "Ali was the people's champion, and champion he did the cause of his people."

**Washington Post:** Washington National Cathedral to remove Confederate battle flags from its windows

Washington National Cathedral, one of the country's most visible houses of worship, announced Wednesday that it would remove Confederate battle flags that are part of two large stained-glass windows honoring Confederate generals Stonewall Jackson and Robert E. Lee. Cathedral leaders said they would leave up the rest of the windows — for now — and use them as a centerpiece for a national conversation about racism in the white church. The announcement comes a year after the cathedral's then-dean, the Rev. Gary Hall, said the 8-by-4-foot windows have no place in the soaring church as the country faces intense racial tensions and violence, even though they were intended as a healing gesture when they were installed.

**Associated Press:** Israel beefs up troops in West Bank after Tel Aviv shooting

Israel on Thursday imposed a series of sweeping restrictions on Palestinian movement and deployed hundreds of additional troops to the West Bank in response to a Tel Aviv attack that killed four Israelis. The shooting, carried out by two West Bank Palestinians, targeted a crowded tourist and restaurant district in the heart of Tel Aviv and was among the deadliest and most brazen attacks in a nine-month wave of violence. The area is located across the street from the Israeli military's headquarters. As Prime Minister Benjamin Netanyahu prepared to meet with his Security Cabinet to discuss further responses, the Israeli military announced that it was deploying two additional battalions to the West Bank "in accordance with situation assessments." The deployment, involving hundreds of troops, includes soldiers from infantry and special forces units.
