All (including especially Governor Nikki Haley) –

So here's a contemporary lesson in exposing government corruption: Sometimes you just have to circling and keep jabbing from different angles until you expose vulnerabilities. After two years of repeated barrages delivered to various elements of South Carolina's Executive Branch and Legislative Branch, the "violation of civil rights under the Constitution of the United States" appears to have hit a soft spot. That's because violation of an individual's civil rights is one of the few forms of government abuse state government politicians, executives, and "law enforcement" cannot "manage".

The humorous thing is, I had to ultimately create the vivid image of a situation requiring urgent action and offering immediate opportunity to get any sort of reaction and be able to finally deliver some effective blows. Kind of like Muhammad Ali's rope-a-dope. Politicians and law enforcement do that routinely. Two years of body blows seem to have created an opening for truth to finally emerge. Amazing I had to spend more than a thousand hours and retain a world class expert (Dr. Ronald Falta) with personal funds to break down the shield of deceit and misdirection maintained by operatives of South Carolina's Executive branch.

I have included a set of email exchanges (all but two my emails) to document several recent communications. Please note that previous emails have documented that SC DHEC managers barred me from communicating with them directly as part of the PSCT DHEC/Kestrel Horizons Beneficiary/Trustee Separation Agreement, which governed the period from July 25, 2014 through October 31, 2014. During that time, DHEC management attempted to induce a manager of Kestrel Horizons to sign and certify false, incomplete, inaccurate, and misleading permit application documents I refused to sign and certify in July. DHEC managers also intervened with a major consultant to the Trust in a meeting that excluded Kestrel Horizons, as Trustee, to agree on supporting the fatally-flawed, decades-long Conceptual Site Model DHEC used to create and maintain the illusion of soundness and security of hazardous waste disposal. DHEC was one of the consultant's largest clients at the time.

You will note I made recent efforts to describe how I might assist with critical elements of the management of the site, indicating I could accomplish that without ever meeting with or interacting with government officials or staff. I knew that was important to DHEC and the Governor because that was a condition of the 2014 Separation Agreement imposed by them.

The fact is, while the elements I offered to help complete are absolutely critical to the Pinewood Site Custodial Trust and to South Carolina citizens, those are artifacts of Kestrel Horizons' ten year and ten month service to the citizens of South Carolina as Trustee which the Executive Branch of the government of South Carolina wants to bury. First, they have no understanding whatsoever of the profoundly essential value of and fleeting opportunity to launch them, but more importantly, these elements will involve capital and operating expenditures. Capital and operating expenditures that add to the other urgent needs for security and containment improvements – all of which, added together, create a serious problem with the "optics" of the "frugality imperative" of Governor Haley. Penny wise and dollar foolish.

Soon, my capability to assist with completing these critical elements will diminish or disappear completely. These elements were my brainchildren. Looks like they will be stillborn, aborted, or bastardized. Too bad. More government waste due to lack of constancy and maintenance of "optics".

By the way – the comprehensive audit I required as part of the Separation Agreement (witness General Counsel Marshall Taylor and Trust Counsel Phil Conner) was recently completed. Immediately below this message is the final exchange with the Pinewood Interim Administrators. True to form, DHEC management has never responded.

Petit crimes committed by citizens get daily coverage with mug shots, yet major, repeated, systematic felonies committed by politicians and government employees in abuse of citizens are rationalized and swept under the rug.

Rob and All: I have received this message and the attached audit letter. I will review it as time allows over the next few weeks.

Two items that stand out in a quick scan of the table in 2.c, which are also included in the table in 3.b.3:

29	7/24/2014	\$ 199,600	No approvals noted. See explanation in 2b.	Supplemental funding for Q3 - 2014 for Improvement Projects (Additional point of compliance groundwater monitoring wells).
30	8/12/2014	\$ 1,048,700		Leachate transportation and disposal, sludge transportation and disposal, and legal fees.

1. Please note that Item 29 was not actually implemented by Kestrel Horizons, LLC, as Trustee, as Kestrel disagreed that the approach proposed by AECOM was appropriate or adequate. SC DHEC interacted separately with AECOM on this issue and the issue of the conceptual site model, excluding Kestrel Horizons, LLC – even though the contractual relationship was between Kestrel Horizons, LLC, as Trustee, and AECOM, as a contractor to the Trust. That is documented by other correspondence between Kestrel Horizons, as Trustee, and SC DHEC, as Beneficiary. Kestrel performed the procurement tasks, and the Interim Administrator actually implemented the installation of the monitoring wells after Kestrel Horizons' last day as Trustee – October 31, 2014. These are budget amounts – not actual expenditure amounts.
2. Item 30 was for direct expenses to the Trust, as noted. After July 25, 2014, I was personally barred from contact with SC DHEC unless Bryan Williams deemed such contact to be necessary and appropriate. Bryan would have prepared this budget request and it was, no doubt, accurate and absolutely required to carry out the functions of the PSCT through October 31, 2014. Some of this budget amount may have rolled over to you, as Interim Administrator. We transferred all the documents regarding trust Budgeting vs Actual on or before October 31, 2014 – so I have no way now of discerning that. We signed the last of the Trust checks for

payment of invoices received through October 31, 2014 at your office on the afternoon of October 31, 2014, so the actual invoicing and payment was up-to-the-moment at the handoff.

3. The attached 2/10/14 letter to Kestrel from Elizabeth Dieck may shed some light on the thinking at SC DHEC. The understanding of SC DHEC's role as Beneficiary was quite muddled at that time. Director Dieck attempted to clarify the dynamics and procedures, but Director Templeton had ordered a complete restructuring of the Trust financials – without a real understanding that SC DHEC would be required to review and digest all of that – and comment on it and approve the final. You have the entire restructuring as Director Templeton ordered; I have no idea what ever became of that attempt to satisfy Director Templeton's notion of “zero-based budgeting” when the practice of SC DHEC managers was, for many years, to direct Kestrel carry over unspent amounts and to direct Kestrel to apply portions of unused budgets with savings to address other budget requests. I understand why Director Templeton wanted a fresh start, but at that point we were trying to untangle a big plate of spaghetti created by combining the recipes of half a dozen cooks at SC DHEC over more than a decade.
4. After Richard Haynes left SC DHEC, the Trust budget approval process at SC DHEC became utterly dysfunctional. No one seemed in charge, accountable for timely decisions, or responsible for meaningful discussions. All – including Director Elizabeth Dieck and Director Daphne Neel - appeared to be virtually paralyzed by ignorance of the process, basic lack of understanding of budgeting and accounting, and fear of making a mistake in the eyes of Director Catherine Templeton and whomever she reported to. That was magnified after the July 25, 2014 divorce decree. I can look in the electronic files we both have to see if I can find an approval, but my educated guess is that by mid-August 2014, the budget approval process at SC DHEC was essentially non-functional, and SC DHEC interactions with Kestrel Horizons, as Trustee, were assigned by default to the new Interim Administrator – whoever that was to be. I will also look to correspondence with you or Ben to see if you were cc'd on any correspondence Kestrel might have had with SC DHEC, as Beneficiary, regarding these items.
5. I'm sure you will recognize the unacceptability and inappropriateness of SC DHEC barring me from communications with SC DHEC, given that I was Managing Principal and 95% owner of Kestrel Horizons, LLC (with my wife, Gail owning 5%). I wish I had instant recall and intimate knowledge of SC DHEC machinations during July 25, 2014 through October 31, 2014 – but I don't and couldn't.

Rob, I will take a look at other aspects of the audit report in the next few weeks and get back to you with questions or comments as they might arise.

On the basis of past behavior of SC DHEC management and staff, I am expecting ambush calls from reporters soon. Clearly I anticipate Director Catherine Templeton's statement at the opening of the meeting on March 10, 2014 in the conference room across from her office, *“Bill, some people might accuse you of fraud....but we will not look back. We will only look forward.....”* will surface again, given that the meeting was attended by many: Elizabeth Dieck, Marshall Taylor, Jackie Dickman (smirker), Daphne Neel (smirker), Claire Prince, David Scaturro, and Cynde Devlin - as well as Phil Conner, Bryan Williams, Brian Haliena, and Chris Suttell. Clearly, that comment was fully loaded and targeted to inflict intimidation and degradation, since all SC DHEC persons present would have had the fiduciary duty to report and pursue any evidence of fiduciary malfeasance. That moment was both the beginning of the end and the beginning of the beginning. Clearly, SC DHEC staff and managers had an authoritative statement to relate at will internally and externally, and Kestrel Horizons staff knew at that point we were cooked and carved.

The fact is, that comment became public within 24 hours of the meeting through SC DHEC staff communications, and has dogged me ever since. I will never recover from that slander – or the smoldering underbrush fire of slander that followed and has continued to spread. You, Marshall, and Rita may recall Ben Hagood repeated verbatim the second part of Catherine Templeton's March 10, 2014 opening remark as his opening remark when we first met after you were selected as Interim Administrator. My response that day was the same as it was on March 10, 2014 – we will examine past, present, and future. And we have and we will, as necessary.

I have attached two of the documents we presented to the group of SC DHEC managers on March 10, 2014. A third is much too large to send as an all-in-one .pdf package. You all have that document – our March 10, 2014 letter to Elizabeth Dieck. Clearly, March 10, 2014 was a watershed day. SC DHEC managers dreaded what we were about to provide – all of which began with a response to a written request by Director Templeton to advise her of any significant risks to the environment at the Pinewood Site which were not being adequately addressed. In the end, that responsible and appropriate request by Director Templeton in early 2014 triggered the Templeton-in-a-teapot situation that quickly emerged. I believe it played a substantial role in ending Catherine Templeton's stay at SC DHEC in early January 2015, as well as creating the political “optics” crisis during the re-election campaign of Governor Haley that catalyzed the end of Kestrel Horizons' role as Trustee, my career, and the life of Kestrel Horizons. This was the Benghazi of the Haley administration in 2014. Casualties happen when politics must prevail over fundamental responsibilities.

By the way – also attached are photographs of the screen on my iPhone documenting the call from Very Special Agent Kristina Gainey of SLED and of Governor Haley's personal security detail – on January 25, 2016 – just a few hours after I talked to the news editor and a reporter from the Greenville News. I had initiated the contact with the Greenville News to provide competent, constructive technical input regarding the proposed coal ash landfill in Pickens County, since the newspaper reports were so full of inaccuracies. The original topic expanded first to Twelve Mile River, then to the Pinewood Site. I had supplied a copy of my CV by email in advance of the meeting. Clearly, the news editor contacted the Governor's office soon after I left, as I barely had time to get home and start a nap before Very Special Agent Kristina Gainey called. I understand Very Special Agent Gainey worked undercovers in the SLED vice operations before joining Governor Haley's personal protection detail. Again, that conversation as well as previous conversations are documented.

Get back when I can. And if you see Very Special Agent Kristina Gainey, give her my regards. She may be calling you if you get up on your hind legs when Governor Haley is emerging as the darling of the Republican Party. The debutant ball is less than three weeks away, now. Look for an interesting web site launch soon. Be careful out there.

Now me.... I fear nothing and no one. And I never, ever will.

**General Counsel Pisarik (please provide also to Governor Nikki Haley), Director Heigel, and General Counsel Taylor –**

Just received the included response from Rob Kerr to my offer to assist the PSCT with completing critical pieces that involve my detailed historical knowledge and systems and tools which were not finished due to the abrupt ending of the DHEC/Kestrel Horizons beneficiary/trustee relationship on October 31, 2014. I'm sure you are aware of the response. Too bad. I could have saved the citizens of South Carolina tens of millions of dollars and unnecessary risks and liabilities without ever setting foot in a South Carolina government office or interacting with South Carolina officials or staff. Fear and inability to manage conflict by collaboration or compromise almost always result in lost opportunities.

No one from the Governor's office, the Legislature, or any other agency or agent of South Carolina government has responded to my very extensive submittals or correspondence in more than two years, now - other than your Director Heigel's acceptance of the offer to brief you in July of 2015. I had thought making those submittals more poignant and pointed through time (if that was even possible) might evoke some sort of response. Marshall - I left a message yesterday that I would appreciate a courtesy call. I no longer expect or anticipate courtesy from you or anyone else in South Carolina government. It was good knowing you before you became part of this gang.

I think the cloak of silence speaks volumes about the lack of ethics and integrity as well as irresponsible behavior of South Carolina government and its leaders and managers. This ambivalence or rejection of legitimate concerns of great magnitude also defines the lack of

diligence intrinsic to South Carolina government in pursuing critical needs and issues of South Carolina citizens. In the case of the Flint, Michigan drinking water debacle, a similar dysfunctional and irresponsible government dynamic was apparent. The issues I have brought forward are far more complex and difficult to address – and state government actions and inactions far more irresponsible and reactionary. Maybe the magnitude and long, hairy history of malfeasance and deceit of the public is why the South Carolina Executive Branch continues to be so recalcitrant in addressing them.

We have changed the configuration of the initial set of *Dirty Stories*. Instead of the more detailed recounting of the Pinewood Site and Twelve Mile River, Volume One will include a Preface followed by short versions (*Dirty Shorts*) of those two situations plus the Aqua Tech/Groce Labs site. A few other very short stories will be added, including a criminal case involving illegal dumping of electroplating waste by a couple and an accomplice who happened to be a monkey. The couple, who I interviewed in detail in Spartanburg County Jail with their attorney, went to the state prison for environmental crimes, the total extent of which involved opening the valve of a 200 gallon container of spent electroplating solution with low levels of chromium and driving 14 miles while it dripped out on the road. I never actually met the monkey, who brutalized a few SLED officers and was sent to Arizona, where the death penalty was administered by lab technicians doing research on deviant primates. All that for less than four drums of diluted waste dribbled over 14 miles of paved road.

Now imagine the consequences of a release of some portion of more than 200 million gallons of far more potent hazardous waste directly into the water supply of one million people because the current elected officials and government managers were knowingly, willfully, and grossly negligent and deceitful. And committed continual acts of malfeasance, while covering up the truth and trying to coerce the public trustee into committing federal and state felonies by conspiring to defraud the public and intentionally ignoring and contravening direct trustee fiduciary responsibilities to the citizens of South Carolina. And all of that resulting in substantial, nearly uncontrolled risks to the South Carolina environment and to human health, as well as unending liabilities for taxpayers totaling hundreds of millions of dollars over the next century. And that with very poor chances of taking successful CERCLA actions against Potentially Responsible Parties (including hazardous waste generators) because the State of South Carolina did not take timely and effective actions to manage risks and costs when they could have and should have. Soon approaching the 40<sup>th</sup> anniversary of a four decade-long *ménage à beaucoup*.

You may have guessed that I have expected and still expect another ambush – or a string of ambushes. You know – “kill the messenger”. This time I am ready and completely liberated of future concerns. Ironical that the ethics and integrity of Governor Haley’s Executive Branch – Nikki Haley being the current darling of the national Republican Party – more closely resemble that of Hillary Clinton’s team at the Office of the Secretary of State. Governor Haley, this is not going to look good on your *curriculum vitae*.

By the way, I no longer expect or anticipate media representatives in South Carolina to report objectively – if at all – on these matters. That is unless and until South Carolina government folks decide to initiate further aggression. Even then, the news folks in South Carolina will bury or downplay just about any story if the *quid pro quo* involves promises of “scoops” on future juicy stories. The “news directors” will certainly help kill (incapacitate or discredit) the messenger. I realize it’s not personal – it’s just good business.

Who can guess what the feds will do? If a Republican gets the White House, probably nothing. If it is a Democrat, the US Justice Department and US EPA will be gunning for the darling of the Republican Party and her cohorts. Guess I have a keen sense for the obvious. That is completely out of my control now.

I feel satisfaction that the ugly truths and facts have now been broadcast and will soon be available at the chattering of mice. The ugly truths and facts stand on their own and I am absolutely irrelevant in the whole scheme of things now. Sometimes nothing is a pretty cool hand.

So good luck to you all. You may need it. I won’t, because the ending to these stories has already been written for me. It was cast in stone two years ago.

Now on to *Meaning*, *Letters to the Earth*, and *There’s Got to be a Monkey in there Somewhere*.

Rob – Here is an idea I had last week. As you have gathered, I remain disgusted with and mistrustful of the Executive Branch of South Carolina government. I may forward to you a recent message to family and friends. In 2012 and 2013 I was full of optimism that we would finally make critical breakthroughs with SC DHEC in management of the Pinewood Site. In 2014, that optimism turned to pessimism and disdain.

That’s not me. At least that’s not the best me – or the usual me. You may have seen some of the spiritual and sociological writings I authored prior to 2014. Even after the challenges of 2011 with my partners and the McNair Law Firm – in particular longtime colleagues Ethan Ware and Ron Cardwell – I remained hopeful and optimistic.

This national battle royale we are experiencing has been an outlet for me to focus my writings on honesty, integrity, and ethics of elected public servants and government employees. The problem is that corruption and dysfunction in all those fundamental traits is so pervasive as to be the norm. Little meaningful differentiation. Distinctions without differences in principles.

I really want to get back to my subject matter pre-2014. Much better for the soul.

Rob, I really do think I could help you and the Pinewood Team a great deal, and contact or interaction with South Carolina government folks would never be required. Over the nearly eleven years we were Trustee, only about ten regular team members in total had substantial interaction with SC DHEC; some of the most substantial contributors never sat in meetings with SC DHEC.

Having said that, my assessment is that Catherine Heigel is a person of character – as is Marshall Taylor. If the Governor backs off and lets the Trust do what is needed, the rancor of the past two years will dissipate very quickly.

I am a consummate team member; only when SC DHEC management tried to induce us to do unethical and irresponsible things – and acts I deemed felonies – did I mutiny. Until that moment on July 18, 2014 even the most controversial and difficult issues were discussed “inside the tent.”

If you retain me to assist, I will be a committed team member. At this point, I have had my say and submitted my documentation. At this point, that’s about all I can really accomplish outside the tent.

Most people have no idea what I can do or have done in my career. I would like an opportunity to talk with you to see how I might make extraordinary contributions behind the scenes. The attachments may reveal some areas of unique contribution potential.

Marshall:

Maybe knowing the sorts of things I could help with would aid in consideration of this approach:

- The Pinewood Site Operations Management System was about 70% completed when we ended our tour of duty as Trustee. The Management system was my brainchild. In the past 20 months I have integrated several components of the Pinewood Site Operations Management System with systems and tools from other systems, including Kestrel horizons’ systems and tools as well as parts of Cryovac, SOCMA, and others. I have also developed an excellent state-of-the-practice Health and Safety Management System for an environmental contractor. All of these are digital, web-based, and robust. I could bring the Pinewood Site Operations Management System to completion. Doing that will save labor costs and preserve the thousands of valuable records in a way the Pinewood Team can readily gain access to and use, as well as provide an organized, intuitive structure for on-going management.
- A post-closure residuals management cell within the Closure Cell (IIIC) or some other location is one way to save tens of millions of dollars and provide for higher capacity management of post-closure residuals. Cell IIIC is state-of-the-practice, and a cell within that double/double lined cell is by far the safest and most economical way to manage post-closure residuals. I could develop conceptual/preliminary engineering for several alternatives, including quantity and cost estimates.
- The leachate treatment system was never completed. DHEC declined to fund the Stage II advanced treatment system treatment testing and design. The treatment building is sized and designed for various arrangements of advanced treatment equipment, including leachate treatment and solids treatment. The leachate keeps getting more and more “stout” – that is, concentrated and variable in composition. Without the second stage, the treatment system cannot serve the needs of the operations and the Trust will be forever at the mercy of the commercial waste business, which is not good – as we recognize from the experience of many in our State and others. I can manage the treatability testing, comparative feasibility analysis, and conceptual design alternatives. Among other things, my role at RMT included building and managing RMT’s technology development, application, and design group.
- The 3D GIS system was also my brainchild. The value of using it at this stage is far greater than most realize. The system is a very powerful analytical and design tool – and the Team needs some help understanding how powerful it actually is. I can help with that.

There are certainly other things, Marshall. I just wanted to describe four.

Marshall – You were not included in the distribution for this message. I consider you a friend, so the message is attached below.

As you can see, I have a lot of national and universal topics to take up in [rubiconpartyofone.us](http://rubiconpartyofone.us) (.com, .info, .org, .me) as well as [Letters to the Earth](#).

I still believe I can be of great value to the Pinewood Site Custodial Trust and the State of South Carolina for several more years.

Over the weekend, Gail asked me what I would say if the Pinewood Site Custodial Trust offered me the opportunity to continue to serve in an advisory capacity for whatever needs the Trust may have.

I told Gail I like that idea. We discussed it and are thinking a monthly retainer of \$8,000 (\$96,000 per year) for five years for Sparrow Hawk Engineering, LLC (the successor to Kestrel Horizons, LLC) would enable me to contribute in meaningful and constructive ways, focusing on the future. At \$195/hour (my rate when we closed out our Trustee role) plus 7% for all expenses including auto travel, the \$96,000 per year would provide for up to 460 hours per year – or an average of just over 38 hours per month. Of course, regardless of the actual hours of service per month or per year – up to 460 per year – the monthly fee would be \$8,000 per month. Sparrow Hawk Engineering, LLC is a licensed Professional Engineering firm and I will maintain professional liability insurance as well as comprehensive general liability and auto insurance.

As I have no realistic possibility of gainful employment in engineering or construction management otherwise, I could be available to PIA pretty much as needed. That would also enable Gail and me to complete the historic Locust Hill Schoolhouse as an event venue and community center focused on families and children with special needs, as well as families of military servants and first responders and home-schooled children. My dance card would then be filled with meaningful, productive activities and that would also eliminate my time available and further interest in South Carolina politics and government management issues and the incorporation of those topics in my writings and publications.

The Sparrow Hawk Institute will be developing internet-based education and training vehicles and networks with universities, colleges, and technical schools as well as individual educators. *The Idea Foundry* will be at the core of The Sparrow Hawk Institute. I will send brochures for Sparrow Hawk Engineering, LLC and the Sparrow Hawk Institute. One of the brochures does not reproduce well as a .pdf, but the Word file is 60MB, so I can't email it. I will send when I can get good .pdf reproduction – or I can mail paper copies.

Just an idea – and one that would produce positive results for all into the future. I see very positive relationships with the Pinewood Interim Administrators, LLC and the Trust's consultants and contractors: I trust all of them. With regard to DHEC and DNR interaction, that would clearly be up to the PIA; however, with the part-time focused role my time would likely best be used in other ways, and my interests lie in engineering and solutions.

Will be happy to discuss further with whomever might be amenable.

**Family Members and Friends – This note is sent to some who asked to be deleted from routine messages because it is personal.**

**I want to share with you an email sent to Governor Nikki Haley of South Carolina and several South Carolina government agency managers as a follow-up to my August 25, 2016 letter to her. You will note Noon, Tuesday, August 2, 2016 as the deadline for Governor Haley to respond.**

**I am sending you this because there is very low probability she will respond at all – or may respond with an attack of some sort.**

**Shortly after noon on Tuesday, I will distribute the pieces submitted to Governor Haley to national media and to the RNC and DNC – as well as others. Since the documents are lengthy and detailed, any mention of this set of scandals will take some time, as media folks will have to do a fair amount of fact checking and inquiry.**

**The point is, I have no idea how I will be painted in all of this, but the *status quo* is completely unacceptable and untenable to me. I would rather fight hard and go down swinging than simply fade away, having allowed unethical politicians and government officials beat me down and defecate on my reputation and life's work. You can rest assured I have acted honestly, ethically, legally, and morally at all times.**

**Having said that, please don't vouch for me. Let the facts come out and speak for themselves. I'm a big boy. To the extent there are beatings to administer and tables to turn, I want the pleasure and satisfaction of doing those things myself. There is always the possibility this will become very rough. That's OK. I'm good with that if that is the way it needs to be. I love beating bullies. Always have.**

**Moving forward, rubiconpartyofone.us will first be populated with existing pieces – some 1,500 pages in all.**

**The next new pieces I will post (on rubiconpartyofone.us) will likely take up the subject of education, demonstrating how the DNC platform is actually readily feasible through the use of the internet – and involvement of many of us worthless old folks. **One series will discuss the very real and natural role of “profiling and discrimination” in survival and preservation of personal welfare of all animal life forms – including humans. The subject most often referred to as “racism”, “bigotry”,**

and “prejudice” has a strong foundation by design.

Maybe those who like to present themselves as menacing sociopaths – but who are really not – need to consider wagging more and quacking less.

That sort of education needs to start at an early age. Illustrating instinctive behavior can best be done with graphics and video clips – rather than words. This education is needed not by way of offering excuses for “prejudice”, but by way of explaining the foundation for the behavior. We all see videos of animals of all varieties getting along; we ought to be able to figure out some ways to do a little better within the human species. But maybe that's just the 4% Neanderthal in me speaking.
