I was a State Paid inmate for a very long time, now on 11/21/2007 there was a incident where I was at the time Lister Con shut in Ridgville SC, the incident was in Medical, I had a few words with the Doctor and the HCA of Medical and after that I was charged with Threatening to inflict harm on a Employee not one Employee but two Employee's.

Went to the Disciplinary Hearing went in front of the Disciplinary Hearing officer 12/4/2007 my plea was NOT GUILTY and the findings were NOT GUILTY and it is on the Hearing Record Book as OK that's why I sent it with this letter, so you can see it over

To me what all that has happened to me and done to me is all of Misconduct by S.C.D.C. Employee's and cover-up, I've not ever in my 56 years been lied to so much, and like I said I've did everything by the Book and still they thank they are right and they are so Wrong

My mother's nephew who is a very well respected man Mr Henry Floyd he is a Federal Judge he is from Pickens SC, he is in VA now wrote to have him call his friend at the FBI and have them look into the Misconduct of S.C.D.C. Employee's, I told her to just let me write to this office because I told her Henry told me a long time ago if you want something done go straight to the Source and the Source being it was this office that put Mr Sterling in office of S.C.D.C. to be the Director of S.C.D.C.

I wrote to him even Mr Sterling all he did was pass the buck to someone else, and all they have done is what "Lie" and send me some where else to be lied to over and over again. over →

after that I went to the canteen, I was found
not guilty, came back and got my paper work two
hours later, went back to the canteen the week ^{after} and they
say you are on restriction for 45 days, this is when
I found out about what they did about the charge of 804
threatening to inflict harm on a Employee that
it was. Reversed from a 804 to a 825 the 825
is a refusing to obey charge now this is all a
Lie I was found NOT Guilty it is on the
Hearing Record for a Reason and that is I was
NOT Guilty, So how did it get Reversed to anything
from a NOT Guilty finding, it was done just to
take my intimate State Pay that's why.

What they did was falsify information
in the computer about me, plus they lied on the
Disciplinary Hearing Record saying, I quote
This is the 1st charge of this nature it is
write down on the Hearing Record, that in other lie
I've been charged with 825 (6) times before
all this happened to me, they lied two times
on a Document also in the computer and it is still
in the computer to this very day and time (I've seen it
5 times)

Plus my Mother has a very good friend at WYFF News(4) here in Greenville SC that she wants to give her all my paper work, which she has all of my paper work from 1988 until 2015 Jan so you see she has the Proof of all this just like I have.

I told her OK if I don't get anything done about this matter at hand by March 20th, 2015 and get my annute pay back and all my back pay she can do what she wants, and she can do it under the Freedom of Information Act, so there is not a thing anyone can do about it not even me.

I even called the S.C. D.C. Attorney they didn't do a thing but lie to, I even had a Employee tell me even if it was a mistake there is nothing she can do about it, that is so Sad I've been told so many lies I don't want to hear it anymore.

Now like I've said I have done it all here and back along way, they tried just to take my state pay, I've put all the paper work on a good plate and still they lie that all they do is lie.
