

This office has reached a settlement with Mylan concerning the reporting of false and inflated AWP's. I am pleased to inform you that the South Carolina Medicaid Program's portion of the settlement is \$865,288.93. The federal government recently settled its analogous claims against Schering Plough through an independent action. Therefore, the funds being transferred to you by my office consist solely of state-share money. My finance division will be in contact with your financial division concerning the interagency transfer.

I wish to thank you, Jim Assey, George Burnett, Rick Hepfer, Rod Davis, and the numerous other members of your office who have assisted with this suit, and I look forward to successful cooperation with your office on future matters.


