I went to a meeting with Dr Pringle on 4/16/2015 and was told I had to withdrawal my child from Andrews High School because she has 27 missed days of which 9 were suspensions because she was tardy 15 times and my daughter and another student exchanged words after the dismissal bell had rang. Hannah has made A's and B's all year long. I was told to homeschool Hannah. I was approved to do that threw Provost Academy in 10/2014 but was told not to by school guidance counselor. Now they will not let my daughter back in the school and Provost will accept Hannah so she can receive her credits for high school but Dr Green and Dr Pringle are refusing to let her back in the school. Her teachers are allowing her to complete work by computer to get her grades on 4th quarter back to an A and B so Provost will accept her. She went 2 days from this fourth quarter then they suspended her 5 days for 15 tardies and would not let her back into school until the meeting. My husband and I own a business in Georgetown county and we have paid property tax on land at 7% since she started school in Andrews Elementary. Hannah has excuses for 5 days of those 27 and 3 days was her granddaddy passing away with cancer. Please feel free to call me at (843)359-5105. Hannah was also taken out of class by an officer. Questioned by an officer and searched by a secretary, I called the school and the principle and the vice principle, neither one knew anything about it. I was not called about it and wanted video tape of all the students that used that bathroom and was denied. Why didn't the school call in the drug dogs after Hannah was searched to find the so called drugs? I also wanted video tape to prove Hannah had not been tardy all of those days because her first period teacher would not change her roll call paper when my daughter got into her class. I talked to Mrs Cumbie about this at beginning of the year. Also, Hannah was bullied by a 12th grader at the beginning of school and proof was given to school nothing was done to the student but when Hannah and this student had exchanged foul language to each other, Hannah was suspended for 3 days and nothing happened to the other student. Mrs Fernell that works at Provost told me to get Hannah's make up work for the days she was suspended and I tried but Dr Green told me that Hannah was not getting anything from her school and I need to withdrawal Hannah now. I told her I was not until she was allowed the make up work which is Georgetown County School Policy. They do not want my child at that school and that is fine but that school is not gonna fail my child when she has been passing her grades.
