More than half the nation's governors have weighed in with mixed emotion on the brewing crisis over unaccompanied and undocumented immigrant children, most of them from Central America.

Note: In a letter last week to Homeland Security Secretary Jeh Johnson, Gov. Nikki R. Haley (R) voiced her concern about what she called the "failure of the federal government" to secure the border. She also thanked him for telling her that the federal government has not and has no plans to house undocumented children in her state.

Gov. Nikki Haley has appointed Dunstan C. Padgett to be the interim sheriff for Fairfield County in the wake of Herman Young's resignation Tuesday, citing health concerns as the reason. Padgett, 48, of Winnsboro, was hired as a deputy sheriff on August 29, 1988 and has served with the department his entire law enforcement career.

Calling her choice "fit and proper," Gov. Nikki Haley has quickly found a replacement for departing Fairfield County Sheriff Herman Young. An executive order signed by the governor on Wednesday has appointed sheriff's Capt. Dunstan C. Padgett of Winnsboro, to become the new sheriff until a special election is held to replace Young.

Note: Haley issued a statement after Young's resignation, calling him an "amazing public servant."

"We are proud to celebrate his wonderful years of service," said Haley. "He is moving on from this post the same way he led the community of Fairfield County, with strength and grace. Michael and I, along with everyone in South Carolina, owe him a debt of gratitude."

South Carolina's public library directors, confident they have the necessary votes in the state legislature locked up, plan to press ahead with efforts to see a library trespass bill adopted into law, even after a recent veto by Gov. Nikki Haley scuttled their hopes, at least temporarily.

Note: Haley, a Republican, urged county governments to adopt local library trespass ordinances as they saw fit. "Rather than a one-size-fits-all solution at the state level, each county government can and should tailor solutions to the particular problems faced by public libraries in their community."
