
Your Freedom of Information Act request dated October 24, 2013 was referred to me for handling. You requested a copy of "recommendation letters, in hard copy or electronic form written by Governor Nikki Haley or written by her staff on her behalf addressed to your agency and recommendation letters, in hard copy or electronic form written by Senator Vincent Sheheen or written by his staff on his behalf addressed to your agency."

The Human Resources Office and Director's Office have searched their records and found that there was one letter received from Senator Vincent Sheheen. However, at this time that letter is exempt from disclosure under S.C. Code Ann. §30-4-40(a) (3) (b).

If you like, we will continue the search for recommendation letters by requesting that each individual in a supervisory capacity in the agency check their records. We estimate the cost of conducting such a search will be \$1,400.00, therefore we are requesting a deposit of \$700.00. Please let me know if you would like the additional search conducted by indicating so in writing and providing the deposit of \$700.00.
