

America is in a crisis. Perhaps the greatest crisis since its birth. The Federal government has become an enemy like King George and is taking away our liberties. We are at war but do not know it, and we are losing. The Supreme Court, along with the Feds, have become our enemy and are oppressing the Americans. This runaway and lawless Supreme Court must be resisted at all cost. We cannot continue to allow them to have authority over the States when they reject the law of the land, (the Constitution) and pass rulings contrary to the Constitution. They make rulings according to their own political agenda and break the law. They have become an Oligarchy – a dictatorship of nine judges who exalt themselves above the Constitution and make themselves the final law of the land. This is tyranny and treason. They should be impeached. The three branches of the Federal government should check each other. The President and the Congress should override the Supreme Court. They won't because they have become a good old boy network. Patrick Henry foresaw this when he fought against the ratification of the Constitution. The Constitution as it stands has many flaws. He said there are not enough checks and balances, and one day, the Federal Government would become another King George. That time has come. The time has also come for the States and the Governors to resist and defy the tyranny of the Federal Government just as our forefathers resisted the tyranny of King George. May God give all the States and it's leaders the courage and conviction to defy the oppression of Federal leaders and in so doing uphold the Constitution and protect the liberties of the American people. The States have become our last hope of defense against their tyranny. If the States will not resist we will soon lose all our liberties.

Let us consider the different ways the Supreme Court is oppressing the American people and have taken away our God given rights. The Court has attacked the freedom of the States to practice Christianity. The Constitution, in the first amendment protects the people and the States from the Federal government taking away the freedom to practice Christianity. The Amendment says Congress or the Feds shall not make any laws or rulings concerning Christian sects or make laws or rulings to prohibit the free practice of Christianity (religion). Christian morality is fundamental to our liberty. It is the foundation of liberty. When you strike at Christianity you strike at our liberty and are an enemy of the United States of America. We are a Christian Republic. When the Court bans the promotion of Christianity and it's morality from our schools it is tyranny. The court has no jurisdiction or authority over our schools. Teachers praying and reading the Bible with students is protected by the Constitution. The Constitution protects the free practice of Christianity in our schools. The banning of prayer and Bible reading with the teacher is evil tyranny.

Another example of tyranny is legalized abortion. Until 1973 abortion (unless the mother's life was threatened) was considered murder. When the Court forces the murder of the unborn on the States, this is overriding the States rights to practice Christianity morality and protect the right to life of the unborn. The Declaration of Independence protects the right of the unborn to live. God Himself commands " you shall not murder." Abortion is tyranny and oppression both to the States and the unborn.

Recently the Court has attacked the institute of marriage and the family and the State's right to protect marriage. When the Court forces the States to legalize same sex marriages it again violates the States rights to practice Christianity by safe guarding the Christian Institutes of marriage and family against the evil of homosexuality. Again this is tyranny and wickedness. The Constitution does not give civil rights to criminals or sexual deviates. Neither does it give to the Court or Federal Government the right to override or abolish state laws based on Christian morality. The Court has no right to prohibit laws based on Christian morality and to force the States to submit to their illegal opinions. The States have every right to practice Christianity and put it

into law. Such laws are protected by the Constitution and cannot be touched by the Federal Government. All the anti-Christian rulings to override the State's Constitutions are oppressive, illegitimate and criminal. They are simply the Judge's opinions being forced on the States. The States have every God-given right to defy the Supreme Court on their evil and illegitimate rulings and protect the people's liberties.

Now is the time for States to resist the Courts tyranny. Some Candidates for office believe the right response is a Constitutional Amendment. This is a farce and a false illusion of righteousness to get votes. By calling for an amendment we are acknowledging the illegal rulings as Constitutional, which they are not. Why must we amend something that is not in the Constitution? None of these evil rulings are Constitutional and need no amendment. To call for an amendment is to establish the Courts illegal ruling as legitimate. Either the President or Congress should simply reject their ruling and override it by calling it unconstitutional. Judicial review given only to the court is tyranny! The States must resist and fight for our liberties for the right to live, the right to practice Christianity in our schools, State buildings, government and to protect the institute of marriage and the family. States have the right to practice Christianity by passing Christian moral laws so America can continue the tradition of being a righteous Nation without the Federal Government interference. Righteousness exalts a Nation but sin is a reproach to any people. Proverbs 14:34 Why do we trust our Federal Government so much? Why have our leaders and people chosen to be so blind and not face how corrupt the Federal government has become. They no longer represent us. Nor do they protect our liberties nor do they obey the Constitution or laws of the land. Just look how Obama and Congress illegally forced Federal Health Care down our throats without a Constitutional Amendment or look how recent Presidents have broken the law by allowing illegal aliens into our country without restraint. They have exalted themselves as tyrants that no longer obey the law and are taking away our liberties especially religious freedom to practice Christianity. They take away our liberties from the States that promote Christian morality so the citizens will be good and righteous. If laws promote moral wickedness then the people will become wicked and our Christian Republic will fall into anarchy, despotism and communism. We will fall like Rome fell with moral rottenness from within. If we do not fall from moral rottenness we will fall with God's judgment. As God destroyed Sodom will he not also destroy us? "The wicked shall be turned into hell, and all the nations that forget God." Psalm 9:17

Since we know the corrupt President and corrupt Congress will not veto the Supreme Court it is up to the States to do it. The States must declare the rulings unconstitutional and illegal thus refuse to obey the tyranny of the Supreme Court. This is civil disobedience and rebellion against tyranny. It is what our forefathers did when they rebelled against King George and fought the Revolutionary war.

We must fight a war of peaceful civil disobedience if we are to save the Liberties of the States from the oppression of the Federal Government. May God give us the courage to obey God rather than man. We must choose God's righteousness over their wickedness to insure God's blessing and our liberties. The Federal Government has become our enemy and is a traitor who has declared war against the people of the United States. Not a war with guns, but with evil rulings that destroy lives and oppress the States and the Americans. The Court is aggressively taking away our Christian liberties. We are losing the war. We must rise up and fight through peaceful disobedience or eventually the States and the people will lose all our liberties. Plus America will cease to be the land of the free and righteous. It will become the land of the oppressed, of wickedness and moral rot. Americans will no longer be a free people of law, but a people oppressed and under tyranny, under the new King George – the Federal Government. All good Americans believe in obeying the law and are against anarchy. But when the laws are evil then we must choose between evil laws or righteousness and liberty. If we blindly obey evil laws that destroy our fellow Americans we are just like the Nazi soldiers who blindly obeyed

and killed six million Jews. Can we blindly obey while over 60 million Americans have been murdered in the name of the law? Will we continue to blindly submit to the tyranny of the Federal Government? Are the Governors and States innocent of the blood of the unborn just because they blindly obey? Of course not! Only when we repent and ban abortion and protect the unborn babies' life again can we stop this American Holocaust and seek for God's mercy.

It is God's will to disobey an oppressive tyrannical government and to save our children from their oppression. The Scripture teach us we ought to obey God not men, when men are tyrants. (Acts 5:27-29) Let us live by the motto our forefathers did: "To rebel against tyranny is to obey God". Passive obedience is sin. Rebellion against evil rulers is righteousness. May God give all you Governors and State Governments and the American people the courage to band and fight for our liberties as "Sons of Liberty" by resisting the Federal Government through civil disobedience by banning abortion clinics, practicing prayer and Bible reading in our schools with teachers, and outlawing same sex marriage to save the institution of marriage, family and our children. May God be with all Americans who chose to rebel against tyrants to obey God. May God bless all the States who chose to defy the Supreme Court and save the babies, our schools, the institute of marriage and protect the free practice of that blessed religion – Christianity. May we love liberty and America and God more than our comfort and false security.
