#1. Anonymous "Greenville Delegation"??? : The program opposition is at it again. Palmetto Promise Institute (Jim DeMint's "conservative" group) has announced its HOPE agenda for education. What is the cornerstone of their (not yet ready) plan ... EDUCATION SAVINGS ACCOUNTS (ESAs).

Palmetto Promise Institute as we all know has been pushing government run ESAs for years ... even getting a bill filed in 2017 (although most of the legislators sponsoring it told us they did not

understand it). Here is the recent timeline of events with their latest efforts opposing the program. We had good news ... so Palmetto Promise Institute had to quickly "announce" their counter plan (even though it was not ready and has no hope of going anywhere). The key being they continue to REFUSE to endorse a program they can not control via their political friends .

- December 12 - Senator Davis files S 131 (Good)
- December 18 - Rep. Elliot files H 3202 (Good)
- December 19 - Palmetto Promise Announces their "(no) H. O.P.E. Plan", but don't have a bill ready to file and they fail to endorse Senator Davis' S 131.

The question is then ... if their HOPE plan is so good ... how were they not prepared to pre-file their bill(s)??? Was it because Brain White was removed from power ... so "their" legislator could not file it. "WHO" specifically are the members of the Greenville Delegation they are referring to? Why not name their supporters? They got their 30 seconds in the press ... good for year-end FUNDRAISING you know ... and they have a catchy name ... H.O.P.E. (Help Our Pupils Excel) ... but there is no HOPE in this "plan". Oh boy, here we go again with the "paid" advocates ... #FollowTheMoney

Recall, Palmetto Promise Institute is the "paid" advocacy group that claims to be conservative ... yet pushes BIG GOVERNMENT SOLUTIONS. We are told Read to Succeed was one such program they pushed ... you know, the program with all the TESTING everyone is complaining about today and cost the state hundred of millions apparently.
