<MSG>My husband is a service connected, disabled, veteran. We moved to SC in November 2014 and, since that time, have been trying to get our exemption for personal property taxes, from the SC Dept. of Revenue. We have submitted our request 3 times and each time, we are told that we don't have the proper documentation. The last documents submitted were exactly as requested by the Department of Revenue, but since the documents were 3 separate documents and the information contained thereon was not listed on a one page document, our application was again rejected. Each time that I have to fax the documents to the Dept of Revenue, it costs me approximately \$10.00. I, too, am 100% disabled and, therefore, my husband and I have a limited income.

We understand that there are rules and that there are those who might try to scam the system, but we have provided everything requested and then some. In addition, the Department of Revenue has told us that they are 10 to 12 weeks behind in processing. So, in the meantime, my husband's car tag has expired and he can't drive.

Total B.S.! It shouldn't take an act of Congress to get a simple form submitted and processed into the system.
