I have been working on this report for the past couple of days and haven't made as much progress as I would have liked. I have attached my current efforts which include the overall findings (which are too long but I really don't know what to cut to make it smaller) and have pretty much done the first four recommendations. I have also just put in a rudimentary recommendation on numbers 5 through 17 (yes I said 17).

What I would like is to get your reaction to the overall findings, the first four recommendations and finally your assessment if I need to do all of the remainder. If not all of them, then which should I eliminate or try to combine. For example, it might make sense for clarity of purpose to combine the two recommendations (6 and 7) on the reorganization of the CIO organization into one single recommendation. Also, should we make a separate recommendation on moving IT procurement into the state procurement agency or will you do that in the overall procurement section? **Marcia has written this one.** Do we need a separate recommendation on doing a complete review and update all IT statutes, regulations and policies in light of all the changes in technology that have occurred over the past twenty years? **Nope, you can mention it as one sentence in your introduction.**
