Kevin, on October 28th, 2015 the occupant of the Office of Executor of the LARRY ANDREA HILL, ESTATE forwarded to your attention Executor letter (registered mail RE469955065US) referencing Warranted Bonded Property Claim RE469954997US, which was delivered on October 29th, 2015. The Executor letter specifically instructed the Office of Director to forward... “to the executor office at postal location as shown above”. The result of your act of Executor Son De Tort is that the Estate’s General-Post Office and the occupant to the Executor Office’s mail / correspondence is being systematically “obstructed” and not being delivered because of undeliverable address for the Estate.

Correspondence from the SCDMV as been returned **as undeliverable as addressed**.

This false claim, an un-warranted act, fraudulently claiming authority to Administrate Estate Property or Interest, regarding general-post office location is hereby Adjourned.

The above mailing location for the Estate and Executor’s Office is known to be a valid mailing location for United States Postal Service purpose.

It is the primary duty of the executor to collect the assets of the estate and he must take into his custody all personal chattels and collect all debts or claims due the estate. Otherwise, the Office of Executor will have no choice but to pursue bond claims.

Therefore, provide a certified copy of your oath for the Office of Director, South Carolina Department of Motor Vehicles and the originating source of your authority to Administer Estate Property or Interest, regarding general-post office correspondence. In addition provide a detailed list of all bonds, sureties, indemnification, insurance, and a full accounting of duly claimed and registered Estate property under Trust Special Deposit [account # DL 004751521] relating in any way to your or any related actor’s personal or professional involvement of intrusion upon the LARRY ANDREA HILL Estate.


Your attention to this situation, and an expedient resolution would be greatly appreciated.
