Bill Chumley's bill (H.4513 <<http://exodusmandate.us8.list-manage.com/track/click?u=2609ca74eb894d07a48096096&id=6d3db5b3e6&e=a47d99d102>>) to enact the South Carolina Natural Marriage Defense Act to nullify the effects in SC of the Supreme Court of the US (SCOTUS) decision to overturn covenant marriage and sanction same sex marriage, also known as the Obergefell v. Hodges decision.

It was attended by 12,000 and is one of the largest such rallies ever held at SC Capitol. This rally shows there is strong popular support for the concepts in the Chumley bill (H. 4513), which is why we invited [Pastor] Trewhella to help carry the issue forward.
