## Hermine Operations Report

(8:00 AM)  
September 3, 2016

**Statewide Summary** – The center of Hermine has exited the state. Wind speeds have returned to normal conditions. SCDOT maintenance crews are continuing to respond to and address roadway flooding. They are mainly clearing tree and debris in coordination with electrical utility crews who are removing downed power lines. Crews in the affected areas are working around the clock.

The ground is saturated and the wind gusts could continue to cause trees to fall onto roadways, therefore the public is cautioned to drive with extreme care. Also if a road is covered with water, “turn around, don’t drown.”

# **District Summary Report**

## **Engineering District 1 (Kershaw, Lee, Lexington, Richland and Sumter Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

All counties have returned to normal operations with on-call crews handling issues as necessary. The District Office has returned to normal operations.

### **Road Closures:**

Six (6) roads closed at this time due to Hermine.

## **Engineering District 2 (Abbeville, Anderson, Edgefield, Greenwood, Laurens, McCormick, Newberry and Saluda Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

All counties have returned to normal operations with on-call crews handling issues as necessary. The District Office has returned to normal operations.

### **Road Closures:**

No roads closed at this time due to Hermine.

## **Engineering District 3 (Greenville, Oconee, Pickens and Spartanburg Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

All counties have returned to normal operations with on-call crews handling issues as necessary. The District Office has returned to normal operations.

### **Road Closures:**

No roads closed at this time due to Hermine.

## **Engineering District 4 (Cherokee, Chester, Chesterfield, Fairfield, Lancaster, Union, and York Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

Most counties are returning to normal operations with issues handled by on-call crews. Chesterfield will begin its 12 hour day shift at 8 a.m. Union county employees are on standby.

### **Road Closures:**

No roads closed at this time due to Hermine.

## **Engineering District 5 (Darlington, Dillon, Florence, Georgetown, Horry, Marion, Marlboro, and Williamsburg Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

Crews are monitoring road conditions and removing fallen trees. The District Office is staffed.

### **Road Closures:**

Seven (7) roads closed at this time due to Hermine.

### **Other:**

The Socastee and Little River Swing Bridges are available for any emergency openings with normal operations by 8 a.m.

## **Engineering District 6 (Beaufort, Berkeley, Charleston, Colleton, Dorchester, and Jasper Counties)**

### **Conditions:**

Conditions have returned to normal throughout the District.

### **Staffing:**

Crews are patrolling roadways to remove limbs or trees, verifying the need of "Water on Road" at flooded areas, or inspecting roadway conditions. The District Office is staffed.

### **Other:**

District 6 Traffic Management Center (TMC) and SHEP will operate extended hours. All movable bridges are operational.

### **Road Closures:**

One (1) road closed at this time due to Hermine.

## **Engineering District 7 (Aiken, Allendale, Bamberg, Barnwell, Calhoun, Clarendon, Hampton, and Orangeburg Counties)**

### **Conditions:**


Conditions have returned to normal throughout the District.
