Dear Madam Governor:

Please allow me a few moments of your valued time in order for me to address my concerns with you, in an attempt to appeal to your sensibility, and ultimately reach a plausible resolve.

On 7.15.14, I was paroled here (S.C.D.C.) from the Michigan D.O.C. (after serving 20 consecutive calendar yrs.), to a detainer for a charge and subsequent conviction which originated back in 1987.

After going through processing at Kirkland

R&E I was transferred here to the Allendale facility. Upon arriving I was placed in Colleton, one of the three designated "Character Housing Units" (C.H.U.). I would later discover that since I've already acquired my GED, and due to the short length of time remaining on my sentence before I max out (1.2.15), that I did not meet any of the criterion for participation in those couple of programs which would prove to be the most beneficial to me at this juncture (ie: CDL and Carpentry). (It should be noted here that I once held a C2 license which I obtained within 8wks. via the Superior Truck Driving School in A.Z.)

I am also being told that due to a detainer lodged against me by Michigan I am barred from qualifying for placement in work release as well. However - because I am only required by the authorities in Michigan to report to an assigned agent upon release, or in the alternative, to call the Interstate Compact Unit, I don't fully understand why such an opportunity would not be made available to someone in my position. Surely I should qualify for some type of "special consideration" based on a grand -

father clause, waiver or something of this nature..... I mean, with all due respect Madam Governor, the most immediate question that begs to be both asked & answered is; would the State of South Carolina really put me out on the streets with only a "BUS TICKET?" Really.... The cats and dogs being prep'd for eventual adoption here at A.C.I are far better situated than I'm finding myself.....

I am only asking/imploing that you would make some special concession to help me, and all those whom may find themselves so similarly situated, help ourselves. The general consensus amongst all who have expressed an opinion on this matter is that the state's sole purpose in having me extradited back down here after nearly 30 yrs. to serve out "SEVEN MONTHS" was to collect the 30 thousand plus it receives for running me through intake. I pray that this is not my only fate/worth.....

Wherefore - I ask that you would take all under careful nonbiased consideration and please render a favorable decision on
