Upcoming SLC Webinar - Interstate Groundwater Disputes and the U.S. Supreme Court

In collaboration with CSG West, the Southern Legislative Conference (SLC) of The Council of State Governments will host a webinar examining interstate groundwater disputes in the United States. **Register now** to participate from **2:00 p.m. to 3:00 p.m. EST, Tuesday, January 24.**

More than 30 interstate compacts govern the use of water from shared lakes and rivers in the United States. However, there is not a single legal agreement in place between states to guide the apportionment of groundwater that crosses state lines. In 2013, Nevada and Utah appeared poised to be the first two states to reach such an agreement, but were unsuccessful. Now, with a longstanding groundwater dispute between Mississippi and Tennessee headed for the U.S. Supreme Court, a legal precedent governing the apportionment of interstate groundwater is imminent. This webinar will address the possible outcomes of *Mississippi v. Tennessee*, implications for interstate groundwater policy and the role of interstate compacts in resolving water disputes between states.
